Dear Water Contractor:

Enclosed is a summary of your water deliveries with corresponding charges for FY 2020 which cover the period October 1, 2019 through September 30, 2020. The summary and review of each contractor's annual water deliveries and charges is the initial step in the process to prepare the FY 2020 Annual Accounting Analysis for each CVP Irrigation and Municipal & Industrial water contractor. The amount delivered (in acre-feet) is shown by month, with the total computed charges by water type. This information is based on data recorded in the Bureau of Reclamation Water Operations & Record Keeping System (BORWORKS) by our area offices.

Your review of the deliveries and charges is very important. Identifying correct deliveries affects the allocation of cost for all CVP contractors receiving similar services to you. Please indicate on page 2 of this letter whether the information on the enclosed WDC is correct. If any discrepancies are identified, please contact the appropriate Reclamation area office for resolution prior to submitting final comments to the Ratesetting Services Branch.

Responses are requested in our office by May 7, 2021. After your review of the information, please return page 2 of this letter by email. Indicate whether the delivery and charge information is correct. Any discrepancies reported will be reviewed and then you will be contacted to discuss any potential adjustments that may be necessary.
