Subject: Fiscal Year (FY) 2022 Water Deliveries and Charges by Month for Central Valley Project (CVP) Water (Action by March 31, 2023)

Dear Water Contractor:

Enclosed is a summary of your water deliveries with corresponding charges for FY 2022, which cover the period October 1, 2021 through September 30, 2022. The summary and review of each contractor's annual water deliveries and charges is the initial step in the process to prepare the FY 2022 Annual Accounting Analysis for each CVP Irrigation and Municipal & Industrial water contractor. The amount delivered (in acre-feet) is shown by month, with the total computed charges by water type. This information is based on data recorded in the Bureau of Reclamation Water Operations & Record Keeping System (BORWORKS) by our area offices.

Your review of the deliveries and charges is very important. Identifying correct deliveries affects the allocation of cost for all CVP contractors receiving similar services to you. Please review page 2 of this letter and indicate whether the information is correct. If any discrepancies are identified, please contact the appropriate Reclamation area office for resolution prior to submitting final comments to the Ratesetting Services Branch.

Responses are requested in our office by March 31, 2023. Any discrepancies reported will be reviewed and you will be contacted to discuss any potential adjustments that may be necessary.
