4/ RRA Full Cost Section 202(3) rate is applicable to qualified or limited contractors that receive irrigation water on or before October 1, 1981.

5/ RRA Full Cost Section 205(a)(3) rate is applicable to prior law contractors leasing land in excess of their entitlement.

6/ In accordance with discretionary provisions under the Federal Register Volume 61, No. 244 Section 426.15, contractors are allowed to irrigate lands in excess of their entitlement. However, they are required to pay an incremental fee equal to the RRA Full Cost 205(a)(3) rate.
