- 1/ Effective March 1, 1996, Cross Valley Canal contract water will be pumped and delivered through the State and/or State's side of joint-use facilities. Therefore, (1) these contractors will no longer be allocated Conveyance costs; and (2) Conveyance Pumping and Direct Pumping costs will be limited to Project Use Energy only. Dos Amigos pumping and State Delta pumping O&M are included in direct pumping.
- 2/ The Conveyance O&M M&I rate is calculated for Folsom-South Canal contractors only and is based on deliveries associated with this canal (see 2007 M&I Water Rates, Schedule A-9).
- 3/ These costs are billed directly to authorities; therefore, no rate is calculated.
- 4/ Refer to 2007 Special Water Rates, Schedule S-3.
- 5/ Refer to 2007 Special Water Rates, Schedule S-4.
