We have completed the fiscal year 2003 accounting for M&I operations, which includes a breakdown of results by individual water contractor and service area. Included in the accounting is an adjustment for the removal of the facility costs and the associated interest impact applicable to Sugar Pine and Sly Park Dams and Reservoirs. This legislative adjustment covers the periods 1949 – 2002.

The net results of operations applicable to your contract(s) for fiscal year 2003 is an operation and maintenance surplus in the amount of \$ «Amount». This includes qualified voluntary payment(s) made during fiscal year 2003, if any.
