**Nature of Action:** The proposed action is for the Bureau of Reclamation to renew livestock grazing leases on twenty-seven pastures within the Newlands Project covered by the in-process Newlands Resource Management Plan (RMP). This CEC will cover renewals of these leases until December 31, 2013. The grazing program will remain the same until the end of 2013, pending the development of the LBAO Grazing Management Plan, which is part of the RMP. The RMP will be analyzing impacts of continuing the current grazing program and alternatives that may arise through the planning process. 
