Mission Statements

The mission of the Department of the Interior is to protect and provide access to our Nation's natural and cultural heritage and honor our trust responsibilities to Indian Tribes and our commitments to island communities.

The mission of the Bureau of Reclamation is to manage, develop, and protect water and related resources in an environmentally and economically sound manner in the interest of the American public.

Background

In accordance with Section 102(2)(c) of the National Environmental Policy Act of 1969 (NEPA), as amended, the Bureau of Reclamation (Reclamation) prepared an Environmental Assessment (EA) in accordance with NEPA, Council on Environmental Quality regulations (40 CFR 1500-1508), and Department of the Interior (DOI) Regulations (43 CFR Part 46) to provide a Water and Energy Efficiency Grant (\$199,938) through the WaterSMART Program to the Bella Vista Water District (BVWD) for its Advanced Metering and Water Conservation Improvements (Project).

This Finding of No Significant Impact is supported by Reclamation's EA Number 16-01-MP, and is hereby attached and incorporated by reference.

Alternatives Including Proposed Action

No Action Alternative

Under the No Action Alternative, Reclamation would not contribute financial funding to BVWD for the Project. The water district may find other sources of money or proceed with only part of the Project.

Proposed Action

Reclamation would contribute \$199,938 to the Bella Vista Water District's Project through a WaterSMART Water and Energy Efficiency Grant. BVWD would provide \$246,312 of non-federal funding. The Project entails the replacement of approximately 80, 1 to 4-inch water meters on existing service connections to meter water usage. The Project also includes the purchase of advanced meter reading registers, smart irrigation controllers, and portable flow meters, as well as funding an irrigation consultant to perform audits and inform water users how they can better conserve water. The project would create an estimated 275-350 acre-feet of water savings annually.

BVWD will phase installation of the meters based upon completion of Endangered Species Act (ESA) and National Historic Preservation Act (NHPA) Section 106 consultations. Because approximately half of the meters can be installed without ground disturbance, and therefore no potential to disturb historic properties or listed species, the district may proceed with installation of those meters. While Reclamation does not anticipate the magnitude of any effects to change as a result of these consultations, completion of the 46 meter replacements listed in Table 1 below will occur only after Reclamation receives concurrence letters from the State Historic Preservation Officer (SHPO) and U.S. Fish and Wildlife Service (USFWS). Once Reclamation receives these concurrence letters, contracting may issue a Notice to Proceed (NTP) to replace the meters listed in Table 1.

Findings

In accordance with NEPA, the Mid-Pacific Regional Office of Reclamation has found that approval of the Proposed Action is not a major federal action that will significantly affect the quality of the human environment. Consequently, an environmental impact statement is not required.

The following are the reasons why the impacts from the proposed action are not significant:

- 1. The proposed action will not significantly affect public health or safety (40 CFR 1508.27(b)(2)).
- 2. The proposed action will not significantly affect natural resources and unique geographical characteristics such as proximity to historic or cultural resources; parks, recreation, and refuge lands; wilderness areas; wild or scenic rivers; national natural landmarks; sole or principal drinking water aquifers; prime farmlands; wetlands (Executive Order (EO) 11990); flood plains (EO 11988); national monuments; migratory birds; and other ecologically significant or critical areas (40 CFR 1508.27(b)(3) and 43 CFR 46.215(b)).
- 3. There is no potential for the effects to be considered highly controversial (40 CFR 1508.27(b)(4)).
- 4. The proposed action will not have possible effects on the human environment that are highly uncertain or involve unique or unknown risks (40 CFR 1508.27(b)(5)).
- 5. The proposed action will neither establish a precedent for future actions with significant effects nor represent a decision in principle about a future consideration (40 CFR 1508.27(b)(6)).
- 6. The proposed action will not have cumulatively significant impacts (40 CFR 1508.27(b)(7)).
- 7. The proposed action will not significantly affect historic properties (40 CFR 1508.27(b)(8)).
- 8. The proposed action will not significantly affect listed or proposed threatened or endangered species, or its habitat that has been determined to

- be critical under the Endangered Species Act of 1973 (40 CFR 1508.27(b)(9)).
- 9. The proposed action will not threaten a violation of Federal, State, tribal or local law or requirements imposed for the protection of the environment (40 CFR 1508.27(b)(10)).
- 10. The proposed action will not affect any Indian Trust Assets (512 DM 2, Policy Memorandum dated December 15, 1993).
- 11. Implementing the proposed action will not disproportionately affect minorities or low-income populations and communities (EO 12898).
- 12. The proposed action will not limit access to, and ceremonial use of, Indian sacred sites on Federal lands by Indian religious practitioners or adversely affect the physical integrity of such sacred sites (EO 13007 and 512 DM 3).
