Proposed Action

Reclamation will execute a Voluntary Partial Assignment of Sacramento River Settlement Contract (Settlement Contract) Number 14-06-200-880X-R-1 from Hiatt Downer Ranch, LLC, Trustee of the Philip B. Illerich Family Trust created under declaration of trust dated September 19, 1995, to Van Ruiten Bros. Reclamation will also update the name of the Trustee for the Illerich Family Trust to Gail J. Owens.

At the time the original Settlement Contract was executed, the property delineated on Exhibit B of the Settlement Contract was owned by the Hiatt Family Trust and the Illerich Family Trust as Tenants in Common, each owning 50% of the interest in the Settlement Contract which conveys 372 acre feet (AF) Base Supply and 212 AF Project Water to the landowners. The Hiatt Family Trust name has since been changed to the Hiatt Downer Ranch, LLC and its interest in the subject property sold to Van Ruiten Bros; the Illerich Family Trust interest was transferred through inheritance to Gail I. Owens.

Article 23(a) of the Settlement Contract provides that the rights and obligations under the contract can be assigned in whole or in part with the written approval of the United States. Reclamation will execute the Voluntary Partial Assignment Contract to convey the new ownership at the landowners' request.

The property is located in portions of Township 12N, Range 2E, Section 7 and Township 12N, Range 1E, Section 12, Sutter County, CA. The Sutter County Tax Assessor's Parcel Numbers are 29-020-009 and 29-020-010. The latitude/longitude is approximately 121°47'43.694"W, 38°53'55.196"N. The property is in agricultural production and will remain so for the foreseeable future.



Reclamation proposes to execute a Voluntary Partial Assignment of Sacramento River Settlement Contract (Settlement Contract) Number 14-06-200-880X-R-1 from Hiatt Downer Ranch, LLC to Van Ruiten Bros and update the name of the Trustee for the Illerich Family Trust to Gail J. Owens. At the time the original Settlement Contract was executed, the Settlement Contract was owned by the Hiatt Family Trust and the Illerich Family Trust as Tenants in Common, each owning 50% of the interest in the Settlement Contract which conveys 372 acre feet (AF) Base Supply and 212 AF Project Water to the landowners. This proposed undertaking will update the names within the Settlement Contract only. No change in land use is associated with the action. No modification to any facilities or construction will result from this action.

Reclamation has determined that the proposed action is the type of activity that does not have the potential to cause effects on historic properties pursuant to 36 CFR § 800.3(a)(1). As such, Reclamation has no further obligations under Section 106 of the National Historic Preservation Act (54 U.S.C. § 306108). Based on analysis of the project activities, I concur with Item 8 in NCAO-CEC-17-04 that the proposed action would have no significant impacts on properties listed, or eligible for listing on the National Register of Historic Places.

This document conveys the completion of the cultural resources review and Section 106 process for this undertaking. Please retain a copy with the administrative record for this action.
