Mission Statements

Background

This Environmental Assessment examines the environmental effects of the Department of the Interior Refuge Water Supply Program's (RWSP) acquisition of up to 40,000 acre-feet (AF) of water from Westlands Water District (Westlands) for Incremental Level 4 (IL4) water supplies for south of the Delta refuges (Refuges). The proposed acquisition is being undertaken pursuant to, and would be in full compliance with, Sections 3406(b)(3) and 3406(d)(2) of Title XXXIV of the Act of October 1992 (106 Stat. 4706) Central Valley Project Improvement Act (CVPIA), which authorizes new water supply contracts for fish and wildlife purposes.

This Finding of No Significant Impact is supported by Reclamation's attached EA Number 17-20-MP hereby incorporated by reference.

Alternatives Including Proposed Action

No Action Alternative

Under the No Action Alternative, Reclamation would not purchase water from Westlands for delivery to the Refuges and requirements under CVPIA would not be met. Absent this water purchase, water available for acquisition from Westlands in 2017 would be held in storage in San Luis Reservoir. There would be no effects to storage in San Luis Reservoir or otherwise as a result of not purchasing IL4 water supply for the refuge, and the Fish and Wildlife Service, the Grassland Resources Conservation District, and the California Department of Fish and Wildlife would not be able to enhance management of the Refuges.

Proposed Action

The Proposed Action is for Reclamation to enter into an agreement with Westlands for a temporary water acquisition of up to 40,000 AF of water currently stored in San Luis Reservoir to help meet water supply needs for the Refuges through March 31, 2018.

The acquired water would be released from San Luis Reservoir and delivered to the Refuges via the Delta Mendota Canal, the California Aqueduct and other conveyance facilities to the Refuges' existing diversion points. The exact amount of water to be acquired each month will vary based upon the actual water needs of the Refuges as determined by the Refuge Representatives and the actual amount of water made available to Reclamation by Westlands, and as determined by actual operations and measurements.

Findings

In accordance with NEPA, the Mid-Pacific Regional Office of Reclamation has found that approval of the Proposed Action is not a major federal action that will significantly affect the quality of the human environment. Consequently, an environmental impact statement is not required.

The following list describes why the impacts from the proposed action are not significant:

- 1. The proposed action will not significantly affect public health or safety (40 CFR 1508.27(b)(2)).
- 2. The proposed action will not significantly affect natural resources and unique geographical characteristics such as proximity to historic or cultural resources; parks, recreation, and refuge lands; wilderness areas; wild or scenic rivers; national natural landmarks; sole or principal drinking water aquifers; prime farmlands; wetlands (Executive Order (EO) 11990); flood plains (EO 11988); national monuments; migratory birds; and other ecologically significant or critical areas (40 CFR 1508.27(b)(3) and 43 CFR 46.215(b)).
- 3. There is no potential for the effects to be considered highly controversial (40 CFR 1508.27(b)(4)).
- 4. The proposed action will not have possible effects on the human environment that are highly uncertain or involve unique or unknown risks (40 CFR 1508.27(b)(5)).
- 5. The proposed action will neither establish a precedent for future actions with significant effects nor represent a decision in principle about a future consideration (40 CFR 1508.27(b)(6)).
- 6. The proposed action will not have cumulatively significant impacts (40 CFR 1508.27(b)(7)).
- 7. The proposed action will not significantly affect historic properties (40 CFR 1508.27(b)(8)).
- 8. The proposed action will not significantly affect listed or proposed threatened or endangered species, or its habitat that has been determined to be critical under the Endangered Species Act of 1973 (40 CFR 1508.27(b)(9)).

- 9. The proposed action will not threaten a violation of Federal, State, tribal or local law or requirements imposed for the protection of the environment (40 CFR 1508.27(b)(10)).
- 10. The proposed action will not affect any Indian Trust Assets (512 DM 2, Policy Memorandum dated December 15, 1993).
- 11. Implementing the proposed action will not disproportionately affect minorities or low-income populations and communities (EO 12898).
- 12. The proposed action will not limit access to, and ceremonial use of, Indian sacred sites on Federal lands by Indian religious practitioners or adversely affect the physical integrity of such sacred sites (EO 13007 and 512 DM 3).
