1.0 Landowner Coordination

The San Joaquin River Restoration Program (SJRRP) proactively engages and coordinates with river landowners and other affected third parties. To facilitate this activity, the SJRRP designated a Landowner Coordinator to serve as a single point of contact for affected parties in the river system. Primary activities of the Landowner Coordinator have included coordinating development and distribution of a Temporary Entry Permit (TEP) for field surveys and investigations, facilitating reach-specific landowner meetings, notifying affected parties of field activities on private and public lands, and performing Third Party coordination.

2.0 Reach-Specific Landowner Meetings

Reach-specific landowner meetings have been conducted since 2007 to keep landowners informed and engaged in SJRRP activities occurring in their area. These meetings have sought to support development of a programmatic TEP and site-specific studies and surveys. A chronology of landowner meetings is shown in Table 2-1. Attachment 1 of this Appendix includes invitations and agendas from the meetings listed in Table 2-1, and Attachment 2 contains copies of the sign-in sheets collected at these meetings.

4.0 Third Party Coordination

The Landowner Coordinator provides technical support to the U.S. Department of the Interior, Bureau of Reclamation (Reclamation) for a variety of activities. This includes support of development of a TEP, distribution of TEPs, and coordination with landowners and Third Parties for the conduct of field activities.

Development of the TEP has been supported by extensive outreach and coordination with the RMC since 2007. This has included attendance at monthly RMC board meetings, periodic RMC Executive Committee Meetings, and a variety of small group meetings focused on specific issues. Topics that affected development of a TEP acceptable by the RMC in 2009, and therefore affected general river access by the implementing agencies, include the following:

- Passage of legislation to accept terms and conditions of the Settlement.
- Development of a “Safe Harbor Agreement” for landowners from Endangered Species Act provisions.
- Elimination of the California Department of Fish and Game and U.S. Fish and Wildlife Service – two of the five implementing agencies of the Settlement – as entities covered by the TEP.
- Cultural, archaeological and biological surveys.
- Withholding of water quality data collected via seepage monitoring wells installed on private lands by Reclamation.
- Preselection of a fish screen for the Mendota Pool Bypass to protect Exchange Contractor water rights.

See Table 4-1 for examples of responses from Third Parties that contributed to delay in development of a TEP and the conduct of field surveys. Attachment 4 includes copies of these responses.

Following approval by Reclamation, the Landowner Coordinator provided the SJRRP office with more than 40 TEP packets for distribution to landowners in Reaches 2B and 4B, and the bypass system downstream of the Sand Slough Control Structure in early 2009. Seven permits were signed and returned by bypass landowners. One signed permit was received from a Reach 4B landowner. This later permit was rescinded (see e-mail: RE: Access to property operated by Bowles Farming Company; June 1, 2009, Cannon Michael in Attachment 4).

Following further coordination with RMC, a new TEP was developed and approved in coordination with Reclamation in June 2009. While prior permits sought to cover all types of surveys and investigations, the scope of the new TEP was limited to geologic surveys and seepage monitoring. Following consultation with RMC on Reclamation's cover letter to the TEP, packets were distributed to landowners in Reaches 2A through Reach 5 and the bypass system in August 2009.

This notice is to inform you that the San Joaquin River Restoration Program (SJRRP) will be conducting field investigations in your area on April 28, 2009 and May 5, 2009.

Who: U.S. Bureau of Reclamation and California Department of Water Resources

What: Up to 15 agency and contractor staff will visit 30 to 35 potential seepage monitoring well sites near the San Joaquin River. The purpose of the site visit is to evaluate ground conditions for access to each site for future well installation and monitoring activities and to conduct environmental clearance activities at each potential well site. Well drilling activities are expected to begin in June 2009. Target depths for these wells are between 40 and 80 feet each. The purpose of these wells, once installed, is to monitor near-river groundwater conditions and river losses from flows released from Friant Dam as part of the SJRRP.

When: April 28, 2009, and May 5, 2009
8 a.m. to 5 p.m.

Where: Staff will make six stops throughout the day as noted below. All potential well sites will be visited on both the April 28 and May 5 site visits.

Spring and Early Fall Biological Resources Surveys Frequently Asked Questions

Q: Why is the Restoration Program conducting this biological resources survey?

A: In compliance with the Settlement (see www.restoresjr.net for more information), the Program is planning to begin releasing flows from Friant Dam into the San Joaquin River. Some of these flows, called Interim Flows in the Settlement, could be routed through the bypass system beginning at the Sand Slough Control Structure. The biological resources survey seeks to identify whether sensitive species or potential habitat for sensitive species are present in the bypass system downstream of the Sand Slough Control Structure that could be affected by the Restoration Program's Interim Flows.

Q: When will the survey take place?

A: Surveys will be conducted between the hours of 8:00am and 5:00pm through September 15, 2009. The starting and ending times may vary due to temperature and weather conditions. Unfavorable weather conditions may require rescheduling.

Q: What are Interim Flows?

A: Interim Flows are research-oriented water releases from Friant Dam as outlined in the Settlement. Interim Flows during the first year are scheduled to be released from Oct. 1 to Nov. 20, 2009, and from Feb. 1 to Sept. 30, 2010. Maximum releases during these periods are 675 cubic feet per second and 1,660 cubic feet per second, respectively, from Friant Dam. The amount entering the bypass system will be less due to losses to groundwater and water supply deliveries between Friant Dam and Sack Dam. Flows are designed to be less than existing channel capacity.

Q: Why are flows being routed through the bypass system?

A: Channel capacity in the San Joaquin River below the Sand Slough is unknown. Until field investigations are conducted and possible improvements are made, the Settlement directs the Program to utilize the bypass system for flows.

Q: How will survey results be used?

A: The Bureau of Reclamation and the California Department of Water Resources will use this survey information to obtain the necessary permits from the U.S. Fish and Wildlife Service and the California Department of Fish and Game to move forward with releasing flows into the bypass system as part of the San Joaquin River Restoration Program. Survey results will provide information on the scope of actions that can be conducted under the Restoration Program, including the timing, volume and routing of Interim Flows in the bypass system.

Q: What happens if sensitive species are found?

A: The purpose of the biological resources surveys is to determine the potential impacts of the Program's Interim Flow releases on sensitive species or their habitats. This information will also be used to formulate ways to avoid or mitigate any potential impacts of the Program on these resources.

Q: When will I be notified of survey results?

A: Within 10 days of the completed survey period. Because two survey periods are planned, survey results for the first survey will be provided no later than July 25, 2009. Survey results for the second survey will be provided no later than September 25, 2009.

As the surveyors walk through the area, they will make visual observations and observations using binoculars. The surveyors will prepare mapping and documentation showing all areas surveyed. Survey results for the second period of surveys will be provided 10 days after completion of the survey (no later than September 25, 2009). Field Activity Advisory May 22, 2009

This notice is to inform you that the San Joaquin River Restoration Program (SJRRP) will be conducting field investigations in your area from May 26 to June 5 at locations where monitoring activities are expected to begin in Summer 2009.

Who: The California Department of Water Resources (DWR)

What: Three-to-four field staff supporting the SJRRP will be making initial site visits in preparation for scour chain and water level recorder installation, cross-section surveys, and other water flow monitoring activities. Staff will visit and assess conditions at 11 transects on the San Joaquin River where DWR plans to monitor river bed and bank changes using cross-sectional and topographical channel surveys. The transects were established by the San Joaquin River Riparian Habitat Restoration Program for its 1999 pilot flow studies. When the channel is dry this summer, DWR will install galvanized scour chains 2-to-10 feet deep at two transects; three transects will be the sites of discharge measurements during flow releases; one transect will be the site of a water stage recorder, where a pressure transducer and datalogger will be installed in a PVC pipe extending into the river channel from the bank.

When: May 26 to June 5, 2009
8 a.m. to 5 p.m.

Where: Eleven transects in Reach 2A of the San Joaquin River with approximate locations and river miles (RM) shown below. (*For reference, RM 216 is at the Chowchilla Bifurcation Structure.*)

Field Activity Advisory Shallow Groundwater Monitoring Wells June 22, 2009

Drilling activities to install a series of wells to monitor shallow groundwater levels near the San Joaquin River are slated to begin the week of July 13, 2009, and continue through January 31, 2010. These wells are the first of many to be installed in support of the San Joaquin River Restoration Program (SJRRP).

Who: U.S. Bureau of Reclamation (Reclamation), U.S. Geological Survey (USGS) and California Department of Water Resources (DWR)

What: USGS drill crews will be installing approximately 35 shallow groundwater monitoring wells at several river locations. The purpose of these wells is to monitor near-river groundwater conditions, including changes in shallow groundwater levels, and river infiltration losses from flows released from Friant Dam as part of the SJRRP. Well installation will consist of drilling a borehole, constructing the well, developing the well, and testing the aquifer. Groundwater monitoring wells will be installed using standard hollow stem auger or mud rotary drilling methods in accordance with all state and local regulations at target depths between 30 and 80 feet each. Wells will be constructed using 2-inch diameter polyvinyl chloride (PVC) pipe. Each installation will take a minimum of three days.

When: July 13, 2009 to Jan. 31, 2010 (est. completion date), 8 a.m. to 5 p.m.

Where: Monitoring well installations will take place at these six locations:

Bathymetric Survey Frequently Asked Questions

Q: What is “bathymetry”?

A: Bathymetry relates to, or to the study of, the terrain and contours of the land underwater, such as a river or lake bottom or the seafloor. Much like topography is the study of land elevation above sea level, bathymetry focuses on depth of land under a body of water as measured from the water’s surface. Bathymetry influences the speed, temperature, and other characteristics of a river’s flow, as water reacts to the river channel’s underwater “landscape.” Bathymetric surveys provide information about the unique shape and features of submerged terrain, which can be used to develop detailed maps of the riverbed, lakebed, or seafloor.

Q: How will the California Department of Water Resources (DWR) perform this bathymetric survey?

A: This bathymetric survey will be performed in Reach 3 of the San Joaquin River (Mendota Dam to Sack Dam) using sonar equipment mounted to a small aluminum boat and assisted by a ground crew who transmit geographic data from nearby surveyor monuments. Surveyor monuments are small brass plaques embedded in structures such as bridges and canal headwalls. Each day of the survey, the crews will hand-carry the boat to a launch facility and launch the boat into the river. The boat will be staffed with two DWR employees who will measure the riverbed using the boat’s sonar equipment. Ground crews of one or two people will use GPS base-station radio transmitters at the surveyor monuments to provide the boat crew with geographic control corrections for the measurements. Other DWR staff may be in the area for support and oversight.

Q: How will the data collected in this survey be used?

A: The data collected during the bathymetric survey will be used by DWR and the San Joaquin River Restoration Program (SJRRP) to assess the river’s channel capacity and ability to convey flows. Programs that are part of DWR’s FloodSAFE California Initiative will use this information to better understand the area’s risk of flooding and to improve the quality of flood hazard data and maps available to local communities.

Q: Will DWR staff collect data about my property near the river?

A: No. Although by California law (Calif. Civil Code § 846.5(a)), professional land surveyors are afforded unique rights of entry to perform surveys unobstructed on public or private property, DWR will collect data only in the river channel. Unless required for staff safety or an emergency situation, no unrequested access to private property along the river channel will occur.

Field Activity Advisory Bathymetric Surveys in Reach 3 August 13, 2009

This notice is to inform you that California Department of Water Resources staff will conduct bathymetric surveys in approximately 23 river-miles of the San Joaquin River below Mendota Pool beginning late August. This survey is being conducted in support of the San Joaquin River Restoration Program (SJRRP) and the FloodSAFE California Initiative.

Who: California Department of Water Resources (DWR)

What: Bathymetric surveys are used to develop topographic-level maps of a river bottom using sonar equipment mounted to a small boat. The boat and its sonar equipment are operated by two people. Boat crews are supported by a ground crew who transmit geographic data from nearby surveyor monuments (small brass plaques embedded in structures such as bridges and canal headwalls). The surveyor monument will be staffed by one to two people. Other DWR staff may be in the area for support and oversight. Ground crews will be in DWR-marked vehicles. Unless required for staff safety, no access to private property along the river channel will occur.

When: August 24 to October 30, 2009 (work is not anticipated from August 31 through September 11) 8 a.m. to 5 p.m.

Where: The team will survey portions of the San Joaquin River, beginning at the base of Mendota Dam and concluding at Sack Dam (Reach 3). The boat will be hand-carried and launched/retrieved at the following locations and possibly others as use is granted:

- Mendota Dam (public launch area)
- City of Firebaugh Public Works Corporate Yard

Called Steve Chedester today as part of preparations in support of the

planned Reach 2B and 4B landowner meetings and to see where we are with the Temporary Entry Permit. Steve brought up the seepage monitoring and mitigation and point-blank asked: "When does Rod Mead start at the RA?"

Here's the summary:

Landowner meetings:

While the 29th is fine for Steve, we need to look at alternative dates due to schedule conflicts for Randy Houk and potentially Chase Hurley. Randy will be out of town on the 29th and 30th (calling in to the RMC meeting) as it's Super Bowl weekend. He suggested Tuesday, Jan. 27, or Wednesday, Jan. 28. Chase hasn't gotten back to us, but it appears his rescheduled January 22nd meeting now falls on the 29th.

Seepage Monitoring and Mitigation:

Direct quote: "For your checklist - Ask Jason: Where is the monitoring and seepage mitigation program that we negotiated during the last round of the legislation?" When asked to clarify, Steve said the group didn't see that topic covered in the MS Project schedule sent by Ali and would like to

know how it will be handled in the Interim Flow EA and the PEIS (i.e. equally in both, or only in one) or another document.

TEP:

The RMC executive committee met Dec. 18 to review changes to the TEP applicable to the geologic surveys. He said this version was used as the committee feels that this activity is a good starting point for the Program. There were no "wholesale changes" to the TEP. For example, the

time of work was amended from 6 a.m. to 6 p.m. to 8 a.m. to 5 p.m. No ESA amendments were incorporated, he said. The committee next plans to distribute the TEP, with cover letter, to a group of prominent landowners for the week of Jan. 5 for review and comment. The document would then be discussed and formally voted on at the Jan. 30 RMC meeting. The cover letter essentially say the TEP is in a form the RMC can generally support, but that it is up to the individual landowner to sign and have evaluated by their own attorney. No copies are available to the Program until Jan. 30. If adopted, the TEP will be posted on the RMC's website. Steve comment that the RMC is not likely to further negotiate the TEP with the Program and "if you change it, don't come back to us."

Rod Mead:

Similar to a certain email, this one caught me by surprise. Steve said you mentioned during a meeting?

Follow-up:

As Steve was pretty firm on issues surrounding the TEP, I didn't press him beyond a few minor follow-on questions. While the stance raises a variety of red flags, we probably don't want to push it at this time (they may be truly benign comments) until Jan. 30. However, if you connect with him on the seepage issue, you might want to touch bases on the TEP.

Hi Cannon-We discussed this some at the last 4B landowner mtg and the March RMC mtg. I think Reclamation and the RMC have an understanding at this point on how to move forward and also understand why certain decisions were made. I made the point at the RMC mtg that I had no intent of misleading landowners into thinking that the version sent out was approved by the RMC and apologized for any misunderstanding. Attached is a Google Earth file that includes coordinates for seven surveyor monuments (small brass plaques) that are needed to conduct bathymetric surveys in Reach 3 of the San Joaquin River. Three of these monuments are in the Columbia Canal Company service area (Randy: See the email from Alex for the jpeg files) and four are in CCID service area (Chris I've also sent the attached to Russell Landon he can open). All with the possible exception of one location, all are on canal structures.

• CCC: Within the CCC area, two of the three are structures on the Columbia Canal. The Nees site is along the Lone Willow Slough. Not sure if that's one of your facilities.

• CCID: One is on the Helm Ditch and three are on Poso Canal. Chase I've cc'd you because one of these is on the flume that crosses over the Arroyo Canal intake.

For the successful completion of the bathymetric surveys of Reach 3 by boat, DWR staff will need to station a ground crew at a monument nearest to the boat. This activity would require a pickup

truck parked near or adjacent to the site and the positioning of equipment that transmits location information to the boat crew. There may be a second ground crew rig positioned elsewhere to relay radio communication from the monument ground crew to the guys in the boat. The second crew would be on a county road.

Please advise on the steps we need to take to coordinate the use of your canal facilities for this survey. Chris: We also request the use of the dirt boat ramp that is next to the Poso Canal Company building that is now (well this June) part of CCID for launch/retrieval of a 12-foot aluminum boat (hand carried). We need to have these surveys completed in June.

Mari:

Please let either Alex or I know if you have Google Earth on your computer. If not, we'll send you picture files. We'd like to work with you on notifying landowners near the monuments (you're one of them, actually), as well as other landowners you recommend. The notification would likely be a field advisory to cover both the on-water activity, as well as the land activity. Our plan is to send this information by mail and email, and post locations and the advisory on the program website's "Field Activities" page. Our goal is to get these advisories to the landowners 10 to 15 days before the surveys begin.

Please keep Alex in the email string, particularly this week. I'll be out of the office until Friday and won't have cell or internet coverage while hanging out at Calaveras Big Trees with my 8-year-old daughter, Hana, and 59 of her fellow second-graders.

Ali, Jason, Kevin:

Spoke with Reggie Hill yesterday regarding a request from the BNLL Survey Team to drive/walk the project levee crest as part of the BNLL survey. As part of the request, I advised Reggie that current in-channel surveys have shown that several sections of the bypass channel are not suitable for BNLL and that a view of other areas in the system (e.g. those that haven't responded or declined requests for entry) from the levee crest by the university could eliminate several properties from further evaluation.

Reggie said he needs legal counsel feedback on the request as the levee crest is a "gray area," meaning the that while the levee may or may not be state property because it sits on private property. If the request is denied, I plan to request a written response (email or otherwise) from the District.

Please advise if there are any further actions or a modification to the above that we need to take.

Yesterday Craig called and indicated that you will probably push the date back in order to make sure that the Program had all the permissions necessary, and we will be delighted to have this presented to the RMC at the August 28th Board Meeting.
2. Poso Canal Company - You are misinformed, CCID does not manage the Canal Company. Nor have we, as Craig told me yesterday, taken Poso over. (He said he heard this from someone else.) Please allow me to repeat the following in writing so that there is no further confusion. CCID under contract simply provides routine and extraordinary (contractual term ... not bragging) maintenance for Poso. Poso does NOT have a manager any nor employees. They have a Board of Directors whom are elected by their shareholders to govern the District. The Poso Board gives permission.
3. I will make sure that the Poso letter gets to their Board right away. Not sure about turnaround.
4. Thank you for notifying the landowners along the river that you will be accessing the river for surveys. That is a little surprising since I haven't heard from any of them about such notice.

Chris,

Thank you for your prompt and thorough response. My voicemail and email to you were the first of several communications Craig and I planned with a number of individuals in preparation for this survey—many of those people are copied on this email, and so I also want to thank you for opening the lines of communication on our behalf. I hope my comments below address questions you raised in your message.

1. Since May, Craig Moyle has had a number of separate conversations with you and with Russell Landon regarding this survey and the control point locations. Craig provided Russell the attached Google Earth files and kept you abreast of their conversations, as Russell stated that he took his direction from you. In these conversations, Russell confirmed that four of these survey monuments (375 Use, Hetfield, x989 and Ulrich) are on CCID facilities, and you explained the need for the letter from DWR for liability purposes. This letter should be in the mail by today.

2. For your reference, I have attached a Google Earth file indicating locations of the monuments DWR proposed as control points for use in this survey, as well as a jpeg of the points as displayed in Google Earth. Russell also indicated to us that the CCID sites are

accessible via CCID levees or public roads. Please let us know if this is incorrect. As confirmed by the Madera County Department of Transportation, the Hammet monument is on a county-owned overcrossing and is available for use. (By cc: Randy, these are the same locations you discussed with Craig in May, June and July and also with Ken Samarin. In emails and phone calls during the week of June 30, Ken graciously allowed DWR access to the Supertanium monument for purposes of the survey. The Nees monument, which is shown on the attached map with the red circle and slash, will not be used because we haven't been able to coordinate access with Darrell Vincent, who per a phone conversation with Shane Burkhart, leases the land from the Burkhart trust.) (By cc: Mari, these are the same locations we exchanged emails about on May 26.)

4. By no means were we expecting you to defend the survey to landowners or other interested parties—that's our job. The program isn't interested in putting you in a difficult position.

5./6. My voicemail and email were to give you a "heads-up" that the bathymetric survey you and Craig discussed would, in fact, begin on August 17 and also to obtain your appropriate address on behalf of Fred Vonderscheer at DWR. We have coordinated site access with private property owners independently from our conversations with you.

7./8. Reach 3 landowners will receive a field advisory via standard postal mail and by email, where possible. We expect to distribute this today. All copied on this email will receive the advisory when it is finalized. Program staff (Jason, Ali and Dave) have discussed this survey during previous RMC and landowner meetings. The program would be pleased to discuss these surveys or brief the group at the August RMC meeting.

10. Russell Landon indicated to us that by the end of June, CCID would be managing Poso's facilities, which is why we came to you. We will take you up on your offer to deliver a letter to Poso's board requesting use of the boat ramp, per your conversation with Craig on Wednesday.

Again, I truly appreciate your thoughtfulness in responding, and I know the Restoration Program and DWR are very grateful for your help.

Alexandra,

Thanks for the messages.

1. The reason for the assurances from DWR was that Craig indicated that the control points that the survey needed for access were located on CCID Facilities. If the survey crew was from a contractor we would have some issues basically relative to liability and comp issuance that would need to be taken care of. The note below seems to indicate that the control points are NOT on our R/W or facilities. The bottom line is ... if the points are on the CCID facilities the proposed letter works, but only as it relates to accessing CCID R/W. For access to points in our service area, that are on private property, you will need to contact that landowner to get permission.
2. Craig also indicated that he would provide a map of control point locations. That would really be helpful since I am now confused. Also with a map I can help in figure out who, if anyone else you might need to talk to.
3. I take it that the determination has been made that TEP's are not necessary for the DWR to access the river for the survey. I think that might be because Land Surveyors have a right of entry. Craig mentioned that the program thinks that there is a right of entry to state navigable streams. I'm not sure either way, and not sure if it matters unless vetted properly.
4. So I am wondering what kind of train wreck that I am going to have to untangle on the 17th? A boat in the river, crews on private property un-announced, at a sensitive time with a note saying "Chris White said its ok"??
5. Are you asking for access by DWR to CCID R/W? then ok.
6. Are you asking for access to points on private property? I have no authority.
7. Do you want to notify landowners that bathymetric surveys are going to commence and don't be alarmed. (Remember, landowners have escorted flood safe surveyors out of the area,

who showed up un-announced, on more than one occasion recently) Probably should have presented the schedule to the RMC (that is why they are there), take advantage of the 'rules of engagement' that we worked out a year or more ago, let the RMC notify the landowners.

8. The RMC just met on July 30th. The SJRRP participates in RMC meetings and reports on upcoming activities. No mention.

9. Mail, email and fax are correct. Any combination are fine.

10. For the at least 20th time, we don't own the Poso Canal facilities or the Sack Dam. Ask the owner whose name I have not the patients to repeat for the 20th time.

Craig, Jason, and Ali, I am willing to help move this along but I need your help also. Do you want me to try scheduling a RMC Exec committee meeting to help expedite?
