In accordance with your recent request and authorization, Ninyo & Moore has performed an environmental database report for a recycled water transmission line project within and around the city of Gilroy in the county of Santa Clara, California (site). This letter report presents our methodology and findings regarding the environmental database report prepared for the site.

SCOPE OF SERVICES

Ninyo & Moore's scope of work for this project included the activities identified below.

- Review of reasonably ascertainable regulatory agency databases from standard sources for the project site and for properties located within a 1,000-foot radius of the site to evaluate possible environmental impacts.
- Identify locations of known hazardous wastes, landfills, leaking underground storage tanks, permitted facilities that utilize underground storage tanks, and facilities that use, store, or dispose of hazardous wastes.
- Address the question of whether the project is located on a site that is included on a list of hazardous materials sites compiled pursuant to Government Code 65962.5 and as a result would create a significant hazard to the public or the environment, as required in Title 14, Chapter 3, Appendix G of the California Code of Regulations.
- Prepare a letter report providing summarizing findings.

ENVIRONMENTAL DATABASE SEARCH

A computerized, environmental information database search was performed by Track Info Services, LLC (TRACK Info) on September 14, 2005. The TRACK Info search included federal, state, and local databases. A summary of the environmental databases searched, their corresponding search radii, and number of noted sites of environmental concern, is presented in the associated TRACK Info report in Attachment A. In addition, a description of the assumptions and approach to the database search is provided in Attachment A. The review was conducted to evaluate whether the site or properties within the vicinity of the site have been identified as having experienced significant unauthorized releases of hazardous substances or other events with potentially adverse environmental effects. The figures on the final pages of the TRACK Info report indicate approximate locations of properties that may pose environmental concerns.

The database search identified several properties of potential environmental concern in the site vicinity on various databases. In addition, 18 unmapped properties of potential environmental concern were identified in the vicinity of the subject site. Based on the address information provided, the databases upon which they are listed, and/or the status of the listing, there is a low likelihood that the environmental integrity of the site has been adversely impacted by 13 of these off-site properties. The remaining five properties are discussed within the appropriate database sections, below.

The following paragraphs describe the databases that contain noted properties of environmental concern, and include a discussion of the regulatory status of the facilities and potential environmental impact to the subject site.

Multiple Agency – Leaking Underground Storage Tank (LUST) List

The Leaking Underground Storage Tanks (LUST) Information System is maintained by the California State Water Resources Control Board (SWRCB), pursuant to Section 25295 of the Health and Safety Code. Also listed are facilities within a one-half mile of the subject site that fall under the jurisdiction of the California Regional Water Quality Control Board (RWQCB) or Local Oversight Program for unauthorized releases by the Department of Environmental Health (DEH) (“County LUST”).

The following table presents a summary of three LUST facilities reported to be located within a one-quarter mile radius of the site, and two unmapped facilities listed on this database.

Multiple Agency – Underground Storage Tank (UST) and Aboveground Storage Tank (AST) Registration List

Information regarding underground and aboveground storage tanks registered with the California SWRCB is provided on the agency's UST list and AST list. Also listed are facilities within a one-quarter mile of the subject site that fall under the jurisdiction of the DEH's UST program. The UST and AST lists consist of properties that have registered tanks, and are not necessarily indicative of sites where a release of hazardous substances has occurred.

Twenty-two facilities were reported to be located within a one-quarter mile radius of the site. Two of these facilities, located at 5887 Monterey Street, are associated with an unauthorized release case and are addressed within the LUST section above. Of the remaining 20 facilities, eight are reported to be located greater than one-tenth of a mile (approximately 500 feet) from the site. Based on the distances of these facilities from the subject site, and the fact that they are not listed on databases that report the unauthorized release of hazardous materials, there is a low likelihood that these eight facilities have adversely affected the environmental integrity of the site. Two of the remaining 12 facilities appeared to be misplotted and are actually located greater than 500 feet south of the site on Sheldon Road. The remaining ten facilities are located within or adjacent to the site boundaries, generally along Monterey Road, Luchessa Avenue, Thomas Road, and Southside Avenue, within the southeastern portion of the site. In addition, one unmapped

property was reported to be located at 855 Luchessa Avenue, presumably at the eastern terminus of Luchessa Avenue. These UST facilities may be encountered during pipeline alignment development activities.

United States Environmental Protection Agency – Emergency Response Notification System (ERNS)

The Emergency Response Notification System (ERNS) is a national database used to collect information on reported releases of oil and hazardous substances. The database contains information from spill reports made to federal authorities, including the United States Environmental Protection Agency (USEPA), the United States Coast Guard, the National Response Center, and the Department of Transportation. The ERNS list contains records for reports for the period beginning October 1986.

One property reported to be located within a one-quarter mile radius of the site was listed. This property, identified as Jacob Villelba, is reported to be located at 5580 Monterey Road. Based on the assumed location of this property, the fact that it is not located within or directly adjacent to the proposed pipeline location, and the fact that it is not listed on databases that report unauthorized releases of hazardous materials, there is a low likelihood that the release at this property has adversely affected the environmental integrity of the site.

California Integrated Waste Management Board (CIWMB), Solid Waste Landfill (SWL) Lists

As legislated under the Solid Waste Management and Resource Recovery Act of 1972, the California Integrated Waste Management Board (CIWMB) maintains lists of certain solid waste facilities located within the state of California (e.g., active solid waste disposal sites, inactive or closed solid waste disposal sites, and transfer facilities).

Two facilities reported to be located within a one-quarter mile radius of the site were listed. The first facility, identified as Burchell Road WTS, is reported to be located at 8155 Burchell Road, within the northwestern portion of the site. According to the database report, this facility is a waste tire location that has been “clean closed.” The second facility, identified as Cencal Tire Recycling, is reported to be located at 6455 Chestnut Street, within the southeastern portion of the site. According to the database report, this facility is a closed waste tire location. Based on the nature of these facilities, there is a low likelihood that they have adversely impacted the environmental integrity of the site.

In addition to the two facilities described above, two unmapped facilities were reported to be located within the vicinity of the subject site. One facility, identified as the City of Gilroy Closed Landfill, is reported to be located at 1500 Southside Drive, presumably at the eastern terminus of Southside Avenue. The second facility is identified as Gilroy Garbage Disposal at the “end of Southside Drive.”

United States Environmental Protection Agency, RCRA Generator (GNRTR)

This database identifies USEPA-listed facilities that report generation of reportable quantities of hazardous waste under the Resource Conservation and Recovery Act (RCRA) program for the identification and tracking of hazardous waste. The list consists of properties that generate hazardous waste, and is not necessarily indicative of sites where a release of hazardous substances has occurred.

Fourteen facilities on this database were reported to be located within one-quarter mile of the subject site. One of these facilities at 5887 Monterey Road is reported to be associated with an unauthorized release and is discussed within the LUST section above. Eight of the facilities are reported to be located greater than one-tenth mile (approximately 500 feet) away from the site. The remaining five facilities do not appear on databases listing unauthorized releases of hazardous materials or wastes, and are not reported to have permit violations associated with hazardous materials or wastes. Based on this information, there is a low likelihood that these 13 facilities have adversely affected the environmental integrity of the subject site.

FINDINGS

According to our review of the environmental database search report, several properties within the proposed pipeline alignment would be considered to be included on lists of hazardous materials or waste sites compiled pursuant to Government Code Section 65962.5. However, proper implementation of soil and/or groundwater management plans and a worker and community health and safety plan could reduce the potential impacts to proposed project activities from known unauthorized releases at these facilities.

LIMITATIONS AND EXCEPTIONS OF THE ASSESSMENT

The environmental services described in this report have been conducted in general accordance with current regulatory guidelines and the standard-of-care exercised by environmental consultants performing similar work in the project area. No warranty, expressed or implied, is made regarding the professional opinions presented in this report. Please note that this study did not include an evaluation of geotechnical conditions or potential geologic hazards.

This document is intended to be used only in its entirety. No portion of the document, by itself, is designed to completely represent any aspect of the project described herein. Ninyo & Moore

should be contacted if the reader requires any additional information or has questions regarding the content, interpretations presented, or completeness of this document.

Our conclusions, recommendations and opinions are based on an analysis of the environmental database report. It should be understood that the conditions of a site could change with time as a result of natural processes or the activities of man at the subject site or nearby sites. The FIDS list is an index of names & locations of sites recorded in various California State environmental agency databases. It is sorted by zip code and as an index, details regarding the sites were never included.

The UST information included in FIDS as provided by the Office of Hazardous Data Management was originally collected from the SWEEPS database. The SWEEPS database recorded Underground Storage Tanks and was maintained by the State Water Resources Control Board (SWRCB). That agency no longer maintains the SWEEPS database and last updated it in 1994. The last release of that 1994 database was in 1997.

Oversight of Underground Storage Tanks within California is now conducted by Certified Unified Program Agencies referred to as CUPA s. There are approximately 102 CUPA s and Local Oversight Programs (LOP s) in the State of California. Most are city or county government agencies. As of 1998, all sites or facilities with underground storage tanks were required by Federal mandate to obtain certification by designated UST oversight agencies (in this case, CUPA s) that the UST/s at their location were upgraded or removed in adherence with the 1998 RCRA standards.

Information from the FIDS/SWEEPS lists were included in this report search to help identify where underground storage tanks may have existed that were not recorded in CUPA databases or lists collected by Track Info Services. This may occur if a tank was removed prior to development of recent CUPA UST lists or never registered with a CUPA.

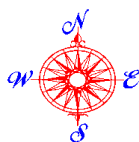

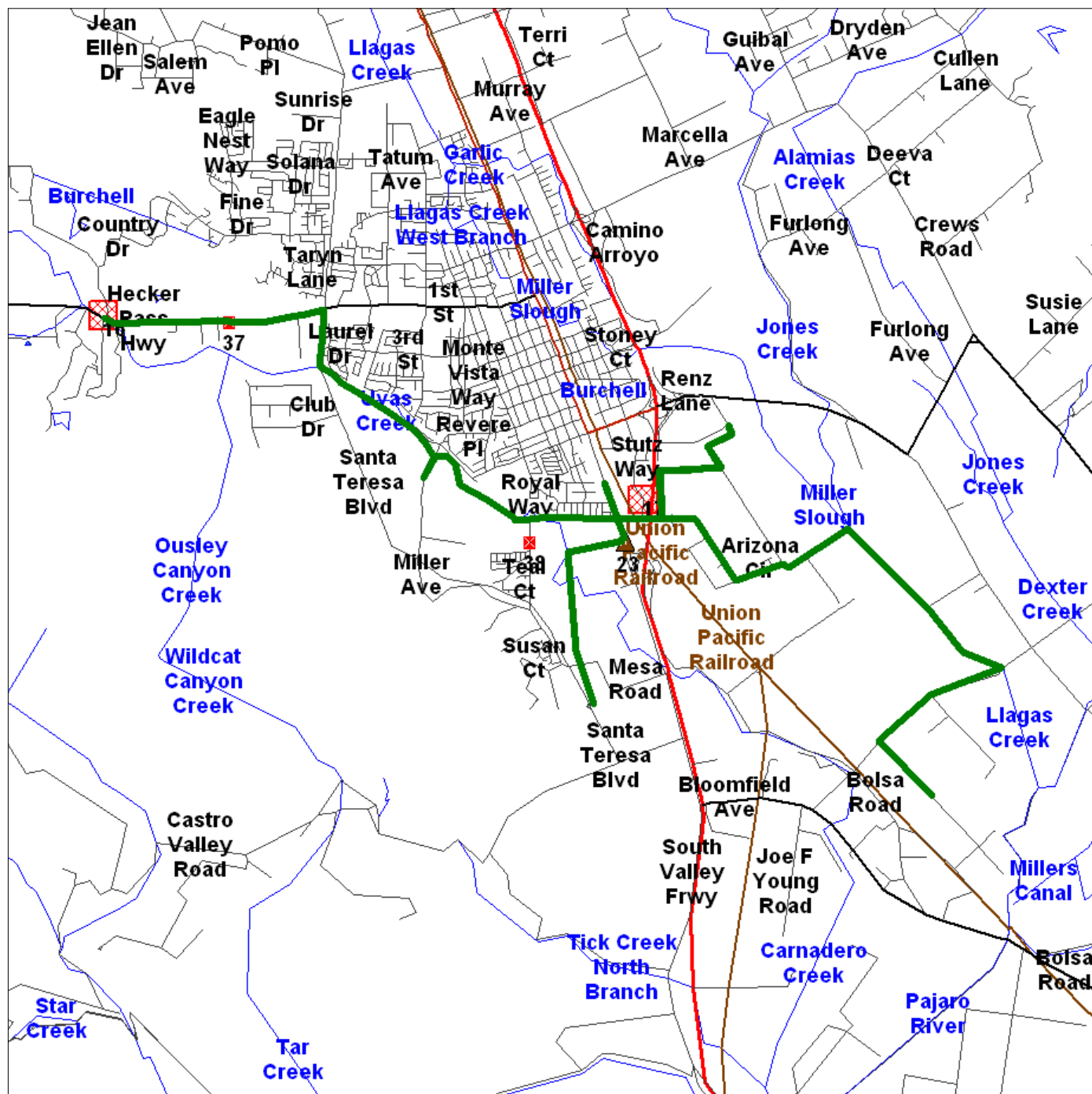

ASTM Map: CERCLIS, RCRATSD, LUST, SWL

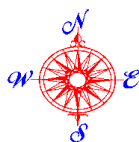

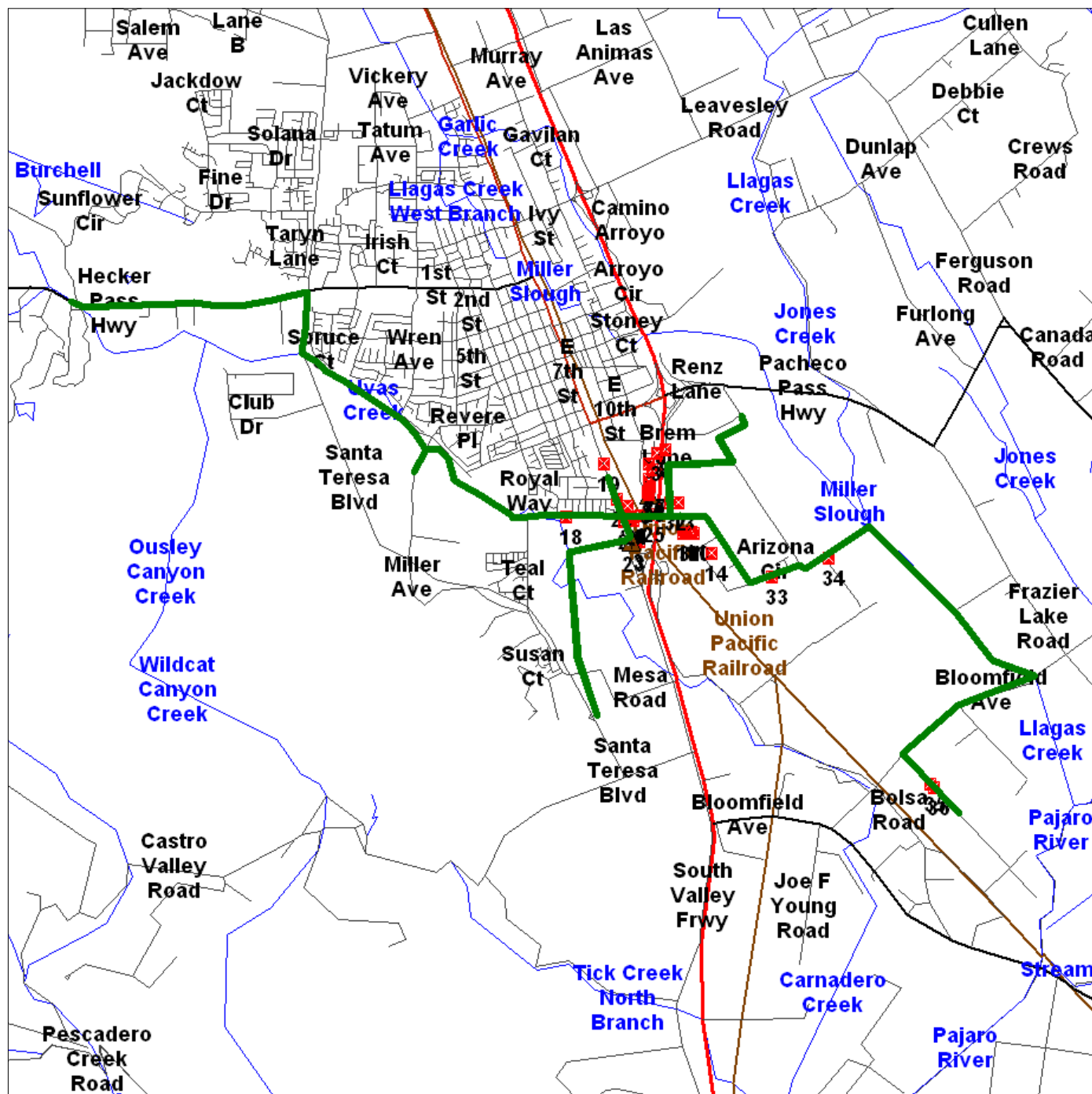

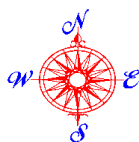

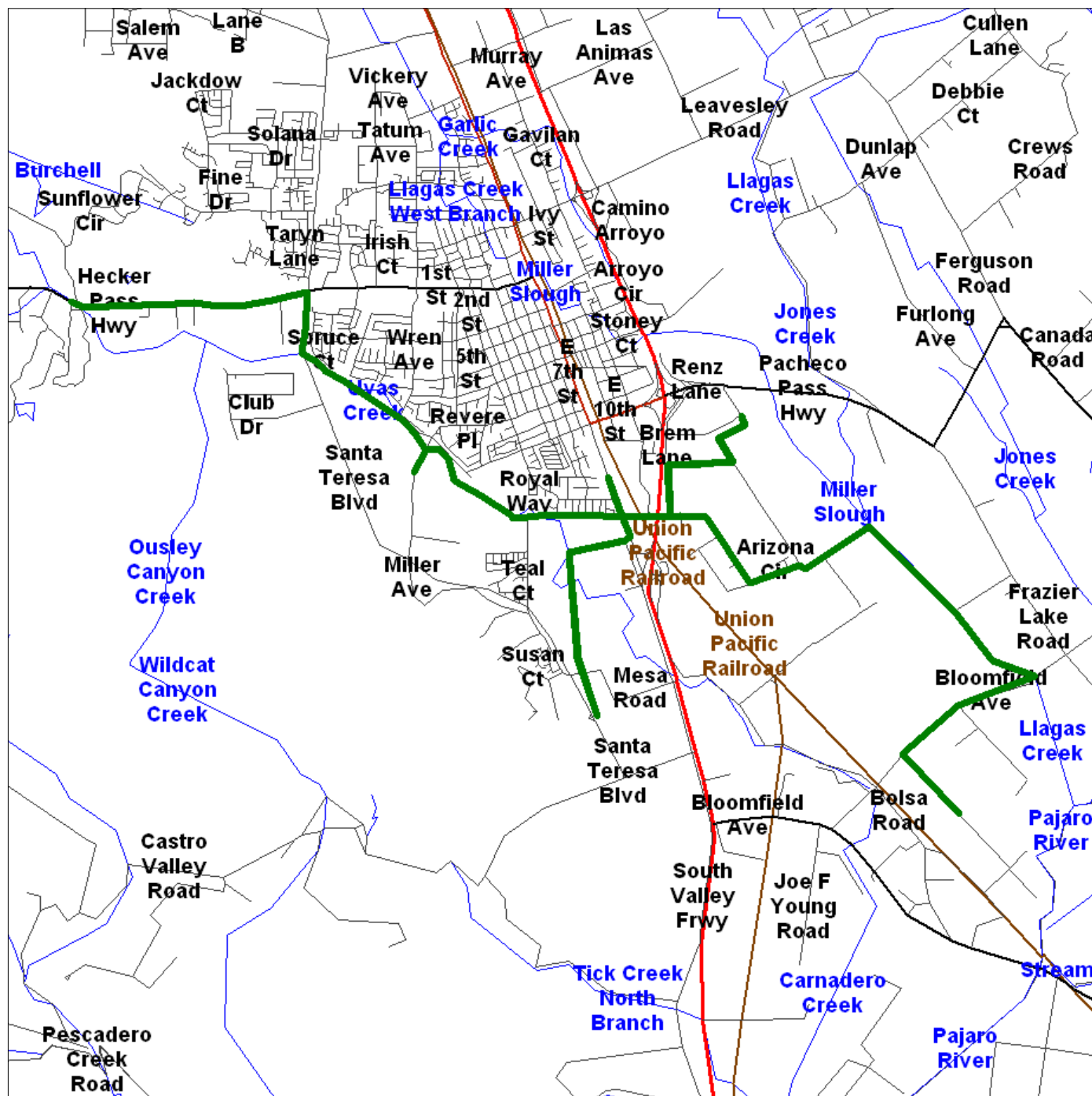

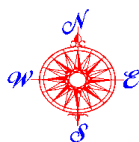

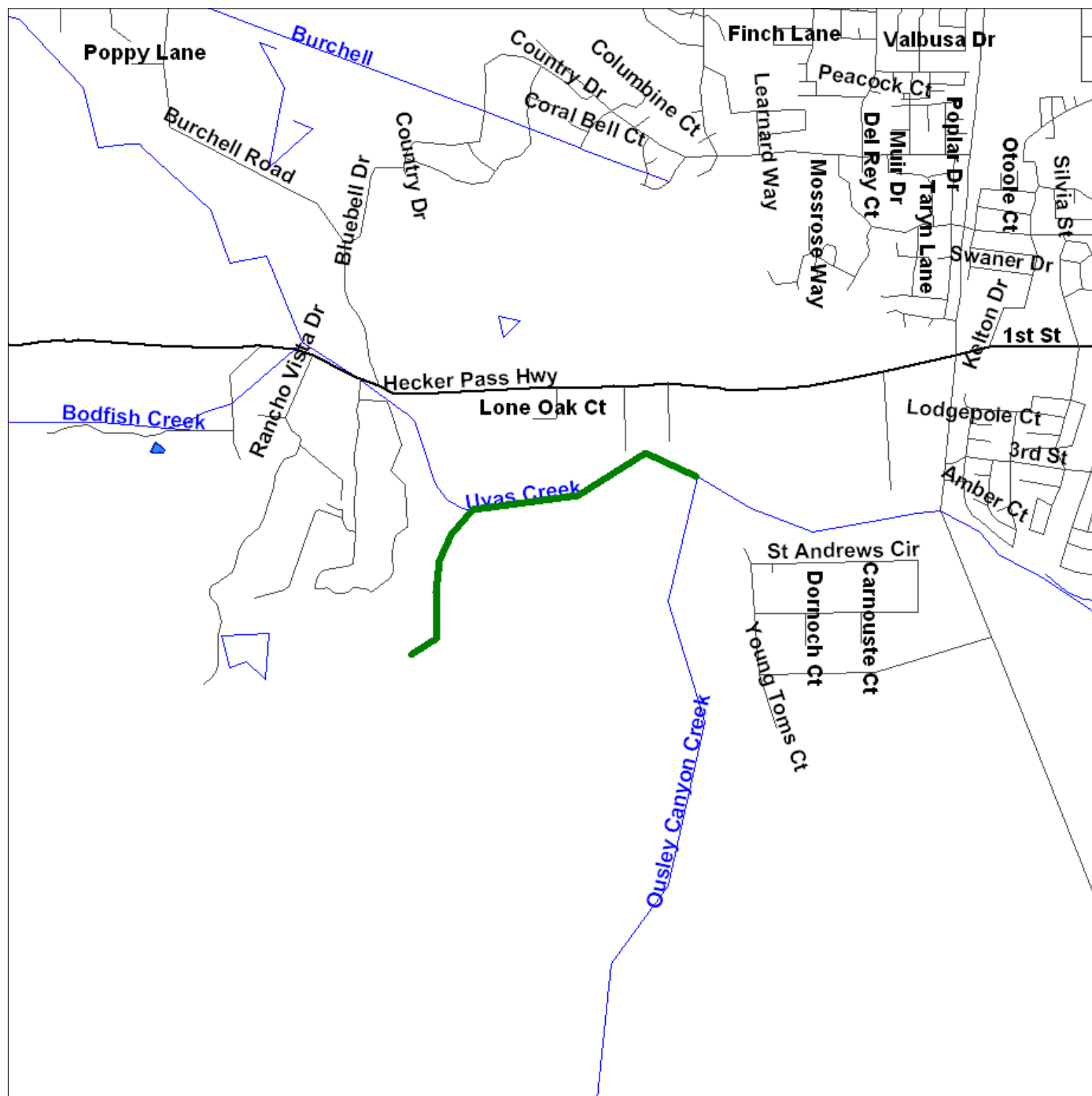

ASTM Map: NPL, RCRA COR, STATE Sites

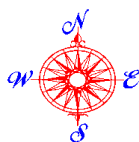

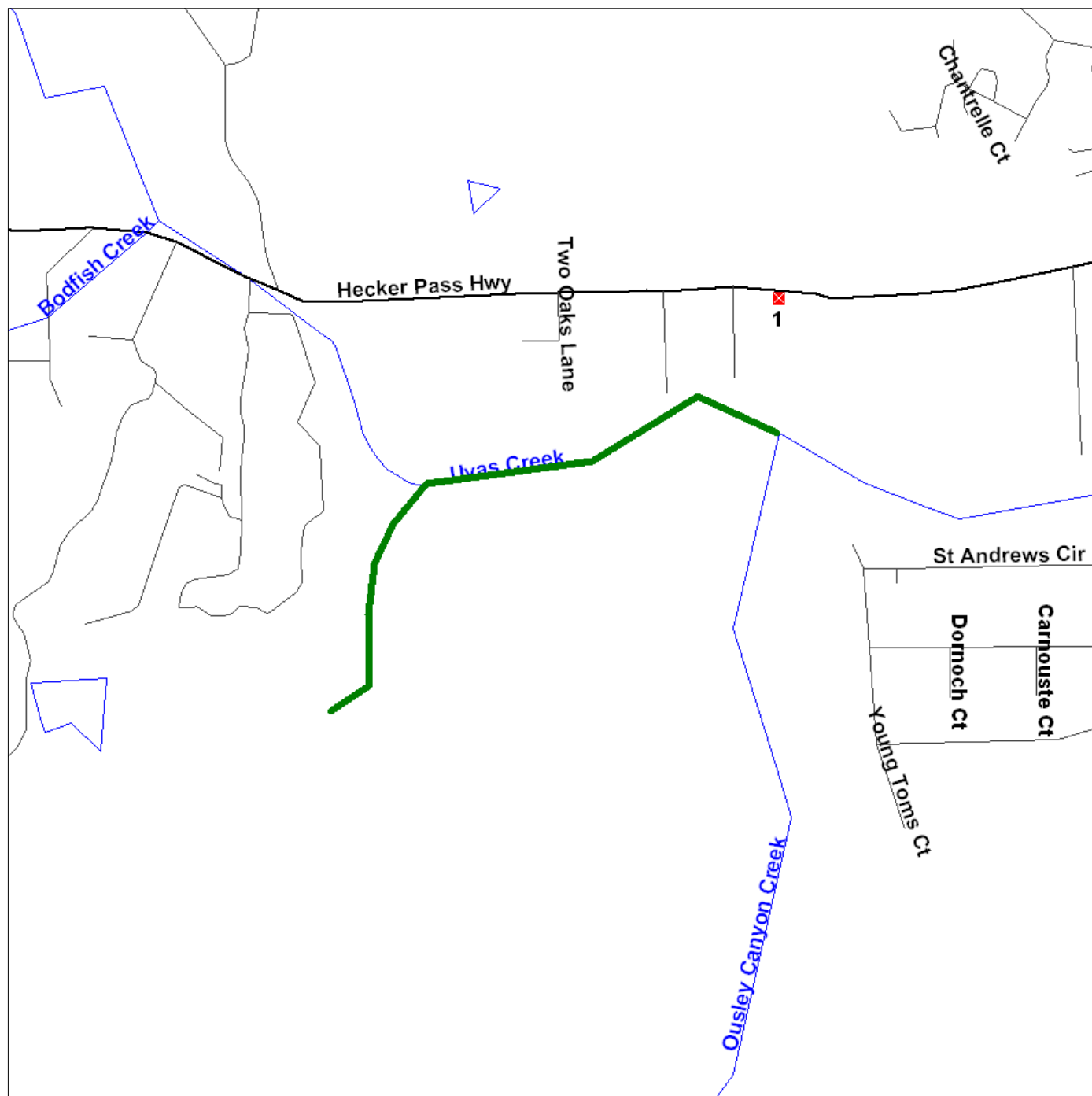

ASTM Map: CERCLIS, RCRATSD, LUST, SWL

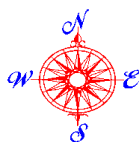
