Also this revised plat shows the irrigable area and classes for each farm unit of the block as designated and established on September 30, 1958 by the Regional Director, Region I, Bureau of Reclamation, for and behalf of the Secretary of the Interior.

The General Map sheets show in tabular form, the imagable lines in each farm unit by classes of and and the portions within each tarm unit required for rights of way or designated as a assisting and interesting the unit of the tabulation in the maps are the tentative class first and made under the provision of the Federal Reliamation caws, these being the Act of line 7, 90% 32 Stations and acts amendatory thereinford supplementary thereing. employed mean. The Topography; She Soil. The use of the symbols indicates the reason that the land was tentatively classed other than in class I. Lands in class 6 are regarded as non-irrigable. Lands designated as "high" are regarded as being at an elevation, beyond the economical reach of the distribution system being provided for the irrigation block. The State of Washington and appropriate counties have furnished; upon the solicitation of the United States, information showing changes in alinement and rights-of-way for public highways and roads under the rightsdiction. To the extent that it has been practicable so to do, these data have been correctly placed and shown on this revised plat. The final irrigable area established for each farm unit, will be announced and fixed for the purposes of water service and project construction repayment by an announcement issued by the Secretary of the Interior to the Irrigation District prior to the end of the development period of the block as provided for in the repayment contract of October 9, 1945, as amended, between the United States of America and the South Columbia Basin Irrigation District, recorded in Franklin County, Washington in Volume 87 of Columbia Basin Documents, page 44.

In considering these revisions, investigations and studies were made of the lands in the block and the project as a whole with the object of determining the area, shape and boundaries of the various farm units in this block, having in mind the requirements of the Columbia Basin Project Act (57 Stat. 14) and of Chapter 275, Laws of Washington, 1943, as amended, and of the policies established thereunder by the Secretary of the Interior. Based on these studies and investigations and all relevant data brought forward since the filling of the farm unit plat, I find that the units as herein revised are of sufficient acreage for the s<mark>upport</mark> of an <u>average</u>—sized family at a suitable living level and have appropriate shapes and boundaries, having in mind the character of the soil, topography, location with respect to the irrigation system, and all other factors that are relevant to the determination of the area and boundaries of the farm units. Accordingly, act ng pursuant to the authority delegated to the Commissioner of Reclamation by the Secretary of the Interior, as shown by Departmental Order 2765, dated July 30, 1954, and redelegated to me by the Commissioner of Reclamation by Commissioner's Order 34, dated October 6, 1954, and Commissioner's Order 34 Amendment E, dated October 29, 1954; all as recorded in the Auditor's office of Franklin County, Washington, in volume 87 of Columbia Basin Documents at page -44, and pursuant to the provisions of the Columbia Basin Project Act as amended, and Chapter 275, Laws of Washington, 1943, as amended, and the repayment contract of October 9, 1945, as amended, between the United States of America and the South Columbia Basin Trrigation District, I hereby revise the farm unit plat of Irrig<mark>ation Block II-, dated February 13 , 1952</mark> , by (1) Replacing the G<mark>eneral Map</mark> sheets of that plat with the General Map sheets of this plat and (2) Replacing supplemental sheets 3, 4 and 11 of that plat, supplemental sheets 1, 2 and 3 of plat revision recorded October 7, 1953, supplemental sheet 3 of plat revision recorded September 7, 1954 as revised, with sheets I through 7 of this plat.
