DEFINITIONS

As used herein, an Irrigation Block is a body of land which is to be put under irrigation at substantially the same time.

A Farm Unit is a unit of land owned by the United States suitable for settlement purposes as determined by the Secretary of the Interior.

A Water Delivery Unit is a topographically delineated unit of land, irrespective of ownership, which is served by a single turnout with a delivery elevation higher than the irrigable land therein.

CERTIFICATE

I hereby certify that this plat of Irrigation Block 25, Columbia Basin Project, Washington is based upon an actual survey of the lands therein; that the distances and bearings for farm unit and water delivery unit boundaries are shown thereon correctly; and that sufficient corners and monuments have been set on the ground to permit an orderly resurvey if necessary.


