This revision consisting of a title page, this sheet showing official actions taken with respect to the plat and the following General Map sheets outlining the farm unit boundaries together with 9 supplemental sheets showing detailed drawings and descriptions of each farm unit, comprises the Tenth revision of the farm unit plat of Irrigation Block 41 of the Columbia Basin Project dated April 2, 1951, and filed for record in the County Auditor's office of Grant County, Washington on April 11, 1951, Auditor's File No. 170293. Previous revisions were made on plats filed April 6, 1953, September 30, 1953, August 24, 1954, August 10, 1955, July 27, 1956, August 5, 1958, August 10, 1959, August 2, 1960 and August 7, 1961.

The revisions in the farm unit plat Irrigation Block No. 41 consist of:

Also this revised plat shows the irrigable areas and land classes of each farm unit in the block as established and fixed on DEC. 12 1962 by the Regional Director, Region I, Bureau of Reclamation, for and on behalf of the Secretary of the Interior.

The General Map sheets show in tabular form the irrigable area in each farm unit by classes of land and the portions within each farm unit required for rights-of-way or designated Class 6 (non-irrigable), or "high". The irrigable areas and land classes indicated in the tabulation on the maps were established and fixed on DEC. 12 1962 by the Regional Director, Region I, Bureau of Reclamation, for and on behalf of the Secretary of the Interior for each farm unit in the Block for purposes of water service charges and project construction repayment as provided for in the repayment contract of October 9, 1945, as amended between The United States of America and the East Columbia Basin Irrigation District recorded in Grant County, Washington, in Volume 1 of Columbia Basin Documents, pages 62 to 123 inclusive.

In considering these revisions, investigations and studies were made of the lands in the block and the project as a whole with the object of determining the area, shape and boundaries of the various farm units in this block having in mind the requirements of the Columbia Basin Project Act (57 Stat. 14) and of Chapter 275, Laws of Washington, 1943, as amended, and of the policies established thereunder by the Secretary of the Interior. Based on these studies and investigations and all relevant data brought forward since the filing of the farm unit plat, I find that the units as herein shown, except those designated as part-time farm units, are of sufficient acreage for the support of an average size family at a suitable living level and have appropriate shapes and boundaries, having in mind the character of the soil, topography, location with respect to the irrigation system, and all other factors that are relevant to the determination of the area and boundaries of the farm units. Also, based on these studies and investigations, I find that there exists in this area a need for units of less than ten acres of irrigable land for part-time farming purposes, and to meet this need I have established the part-time farm units as herein shown. Accordingly,

acting pursuant to the authority delegated to the Commissioner of Reclamation by the Secretary of the Interior, as shown by Departmental Order 2765, dated July 30, 1954, and redelagated to me by the Commissioner of Reclamation by Commissioner's Order 34, dated October 6, 1954, and Commissioner's Order 34 Amendment 1, dated October 29, 1954, all as recorded in the Auditor's office of Grant County, Washington, in Volume 2T of Columbia Basin Documents at page 699, and pursuant to the provisions of the Columbia Basin Project Act as amended, and Chapter 275, Laws of Washington, 1943, as amended, and the repayment contract of October 9, 1945, as amended, between The United States of America and the East Columbia Basin Irrigation District, I hereby revise the farm unit plat of Irrigation Block 41 dated April 2, 1951, as revised, by (1) Replacing the General Map sheets of that plat with the General Map sheets of this plat and (2) Replacing supplemental sheet 4 of the plat revision filed August 24, 1954, supplemental sheet 6 of the plat revision filed August 10, 1955, supplemental sheets 3 and 9 of the plat revision filed August 10, 1959, supplemental sheets 1, 2 and 6 of the plat revision filed August 2, 1960 and supplemental sheets 1 and 2 of the plat revision filed August 7, 1961 as revised, with sheets 1 through 9 respectively, of this plat.
