Subject: Fiscal Year (FY) 2022 Rates for Technical Service Center (TSC) Work

Attached are FY 2022 TSC base billable labor rates, premium rates, and fees associated with unique services, interagency agreements, and interns. Note that the labor rates have increased slightly from FY 2021 rates, primarily due to the increase in Bureau-wide Indirect Cost (BIC) and an anticipated cost of living increase.

And finally, TSC will continue to offer the services of temporary summer hire students and technicians, at a reduced rate of \$25/hour (\$200/day).
