ilo, Michael. I hope this message finds you well, and that your travels back home were satisfactory.

You asked me for some ideas for addressing the issue of acting on motions or consensus items at AMWG meetings. Here are my recommendations:

- 1. Every line on the agenda, in the column headed "Purpose," should include the following: "Information, discussion, and possible action." That way, regardless of what comes up during that discussion, it will be adequately noticed.
- 2. I don't know the legalities of this, but if possible, there should be an indication (both in the Federal Register and on the agenda) that given the nature of the work of the AMWG, there are issues that can come up at the last minute that may need action at the AMWG meeting. This may not be possible, but I think it would be worth asking the question and seeing if we can have some kind of blanket statement. However, if we do #1, it could cover many of the contingencies. (For example, the motion on the flows could have logically come under Tom Ryan's presentation on the drought.)
- 3. There should be a notice on the agenda that items could be taken out of order, and that the time stated on the agenda is only approximate. No one has brought this up as a problem yet, but I have seen this in other agendas of groups subject to open meetings laws.
- 4. We need to find a way to have the presenters for the various agenda items be more clear about what, if any, action they are looking for from the AMWG. These action items should be specified in the agenda packet, with the recommended (or requested) action noted, and some discussion about the action requested. This will ensure that the AMWG members have the opportunity to be more prepared before the meetings. I can assist with this through dialogue with the various presenters well before the meeting, if we can get the draft agenda drafted earlier. The Bureau can also insist that they receive meeting materials in time to be put in the packets, if the person wants to present at the meeting. (Of course, there will be things that change in the last 30 days before the meeting, but I think the members will appreciate having the information earlier, instead of hearing at the meting that they are to take a decision on a difficult issue.)

nagine that Linda and Dennis will have some things to add to this list, or some ways to make these suggestions better. I will look forward to hearing some feedback from you on these recommendations. MO

Just to let you know, one of the documents that was posted to the AMP web site (refer to my e-mail message of 10/5/04), was pulled. The report, "A Discussion of the Evidence for Perceived Failure of the Modified Low Fluctuating Flow Alternative (MLFF) to Benefit Most Ecological Resources Below Glen Canyon Dam, 1991-2001" has not been peer reviewed. In accordance with USGS review protocols, no reports are to be released until they have gone through a peer review. GCMRC will provide an update on the status of the report at the AMWG meeting.

Copies of the new and improved GCMRC Draft Strategic Plan will be handed out at the AMWG meeting on October 25. Based on input from GCMRC staff and the Science Advisors, the Chief decided to upgrade the document to provide significantly more information, particularly with respect to strategic science planning. Such planning was encouraged by the Science Advisors in their June review of the first draft, and echoed by various TWG members. Renewed efforts to address this issue required that GCMRC and the Science Advisors continue development of the draft until just prior to the AMWG meeting. A complete review of the document and the process by which it was produced will be presented at the October meeting.

Here is the latest in terms of proposed schedules for Technical Presentations at the Sept. and Oct. meetings:

September 27-28, 2004 TWG Meeting - 1) Randy V. can only present his native fishes augmentation report findings to the TWG on Sept. 28th, as he takes out from the seining trip on the 27th, 2) Josh K. can present his preliminary findings on redds mapping and mortality + preliminary data on downstream warming studies, presumably on either date and 3) Barb Ralston has requested a slot for Mike Kearsley to present an update on his terrestrial monitoring and research project, again either date may work.

October 25-26 AMWG Meeting - 1) Phil Davis is prepared to present his findings and recommendations from the 3-yr remote sensing initiative (one year after he presented the preliminary findings to the TWG). As you may recall, we distributed his final report to the TWG and AMWG members a few months ago. I suggest that this topic be added to the TWG agenda for discussion prior to the AMWG meeting, perhaps with the objective of even formulating a recommendation to the AMWG for implementation of one or more of the formal recommendations. This is obviously a major component of any core-monitoring plan and I think that the group needs to address the outcome of this multi-million dollar research effort.

I also propose that Jack Schmidt and David Topping make a final joint presentation to the AMWG at their January 2005 meeting, as I have yet to receive Schmidt's final report and Topping is not available for a joint talk at the October AMWG.
