

# Engaging Navajo Nation Chapters in Historic Preservation and Survey Research

## Navajo Nation Government Structure

- As a sovereign nation, the Navajo Nation has a central government
- Three Branch Government
  - Executive President & Vice President
    - 11 Divisions including Division of Natural Resources
- Legislative Speaker of the Council, 24 Delegates representing 110 local Chapter Communities
- Judicial Navajo Courts
- The Navajo Tribal Government is located in Window Rock, AZ



#### Research on the Navajo Nation

- The Navajo Nation Cultural Resources Protection Act (1988) created a cultural resources investigation permitting system.
  - Heritage and Historic Preservation Department oversees researcharchaeological and ethnographic

The Navajo Nation also created an Institutional Review Board (IRB) to oversee research involving human subjects and Navajo tribal members

#### **IRB Research Protocol Application Guidelines**

- The IRB is located Under the Division of Health
- Research proposals must be submitted to the IRB Chair:
  Letter of Interest
  Application to Chair
  Researchers are then scheduled for the next IRB meeting

- Abstract of the research project
- Community involvement
- Benefits to the Navajo Nation
- Research Project Description
- Informed Consent Description
- Certifications by the Private Investigators



Support letters from the CEO's of NAIHS service units and NN Program Directors

Copies of other approved IRB letters

Copy of written letter to the NNHHPD Office for ethnographic interviews (if applicable)



Certificate of Confidentiality (if necessary)

-Budget Outline

-Class C Permit from HHPD-THPO

All audio or videotaped interviews with individuals or focus group(s) will need to submit a Class C Permit Application with the Heritage & Historic Preservation Department
