MOTIONS AND VOTES

Michelle Garrison (Colorado) was elected to serve as Technical Work Group (TWG) vice-chairperson. Elections for chairperson and vice-chairperson will occur in June as usual.

Steve Wolf nominated Michelle Garrison from Colorado. Seconded by Peggy Roefer. Approved by the TWG by consensus.

January 2021 TWG meeting minutes, as distributed as draft on 3/22/2021, were adopted as final by consensus with no revisions.

ACTION ITEMS

- 1. Outstanding Items from January 21, 2021:
 - a. Larry Stevens / Administrative History Ad Hoc Group will convene prior to the annual reporting meeting to consider featuring Administrative History interviews at future AR and TWG meetings. There was also a suggestion to include monthly highlights on the Wiki page.
- 2. **Reclamation** will recommend Clarence Fullard to the Secretary's Designee to serve as the Reclamation vice-chairperson and Reclamation's TWG member. Kerri Pedersen will be nominated to serve as Reclamation's TWG alternate.
- 3. **Reclamation** will update the GCDAMP web page to include the budget procedures document for the Triennial Workplan and Budget process, as approved by AMWG on March 6, 2019.
- 4. **Seth Shanahan, SNWA and TWG Chair,** requests all members review (for their own participation in) the Ad Hoc Group List and respond to Seth and Tara with any revisions.
- 5. **Mark Wimer, GCMRC** will respond to Nevada and CREDA comments on the FY2020 annual report on expenditures via email and will share the response letters with the TWG.
- 6. **Craig Ellsworth, WAPA and BAHG**, created a presentation about implications of a potential 7.48 million acre-feet release in WY2022. That presentation will be made available to the TWG by Reclamation to solicit feedback by TWG members and to foster further discussion at the June 2021 TWG meeting.
- 7. **The TWG charged the BAHG** to examine and approve the second year of the 2021-2023 GCDAMP Triennial Workplan and Budget before the June TWG meeting. The BAHG will also start to consider this year criteria for budget prioritization during the next Triennial Work Plan.
