  - Project Participants working together at ways to assist City of Gallup with well installation opportunities
- 11) San Juan Lateral Intake (aka Reach 1) Status/Schedule (Reclamation)
  - a. SJR Intake Pumping Plant Rehab and SJGS Reservoir Modifications
    - i. Reclamation working through VE proposals to make final recommendations
      - Reclamation to set up focus call about VE proposals
      - VE report(s) to be shared with Project Participants
      - Reclamation to set up meeting with Participants to discuss critical VE proposals
    - ii. Reclamation divers inspected reservoir outlet works and found nothing of

    - i. 30% design expected April
    - ii. VE planned for June

- 14) Block 4A-4B Status/Schedule (Reclamation)
  - a. Award expected in February
  - b. Construction start expected in spring
- 15) Reach 27/Pumping Plant #8– Status/Schedule (City of Gallup)
  - a. 27.7B is currently advertised. Pre-bid tours going on today.
  - b. 27.12 In design
  - c. PP8 In design
- 16) Tohlakai Pumping Plant
  - a. Interim Groundwater Delivery from Twin Lakes Well (Navajo Nation/USBR/City of Gallup)
    - i. Reclamation to install backflow prevention on Reach 12A in order to deliver water to Gallup
- 17) Reach 14 (Indian Health Service)
  - a. Reaches 14.1 and 14.2 Status/Schedule
    - i. March 20 is estimated construction start date
    - ii. Completion expected in August 2024
    - iii. IHS to talk with Reclamation about extension for the funding agreement
    - iv. 14.1/2 Design costs were taken care of in-house by IHS
    - v. IHS has included construction management costs in the 14.1/2 cost estimate
  - b. Reaches 14.6a, 14.7a, 14.8a Status/Schedule
    - i. Design costs are not included in 14.6a/7a/8a
    - ii. IHS to estimate design costs and provide to Reclamation
    - iii. Construction start estimated to be August 2024
- 18) BBN9 Status/Schedule (Navajo Nation/SMA)
  - a. BBN9 has issued a letter regarding the VE proposals
  - b. 10.1.1 moving to 95% integrating a changed in the turnout location
  - c. 10.2.1 working on 90% design SMA paused for the VE and proposals are being integrated into designs
  - d. 10.3.1 working toward 90% design
  - e. Cultural Phase 1 and 2 for 10.1.1 is complete
  - f. Cultural Phase 1 on 10.1 and 10.2.1 beginning in February
  - g. Johnny Johnson:
    - i. Coyote Canyon was able to receive TIFF funding to help with funding
    - ii. Concerned about BBN9 being fulling funded and chapters and doing what they can to come up with funding
    - iii. Resolution will be forthcoming to request to fully fund BBN9
  - h. Reclamation to send the Nation email to set up call about FAA withdrawals
- 19) San Juan Lateral Community Connections (Navajo Nation/SMA)

#### **CUTTER LATERAL**

- 20) Construction and OM&R Update (Reclamation/NTUA/Navajo Nation)
  - a. Operation Update (NTUA/Navajo Nation)
    - i. CLWTP is producing about 270k gallons/day...down from summer months
    - ii. Found a water spot on Reach 22 but the water dried in winter and nothing was found following excavation
    - iii. Considering additional storage at reg. tank 3 to give operators more reaction time

- iv. Working with Reclamation to design new R21 Booster pump
- v. Will submit workplan to Reclamation in coming months as required by O&M waiver
- vi. NREL report has been received for renewable energy and is currently in review at NTUA
- vii. Reclamation and NTUA have been working together collaboratively on lateral-wide emergency plan
- b. Reaches 24 26 Construction Closeout and JAN Water Delivery (Navajo Nation/NTUA/SMA)
  - i. 11-month inspection completed received and concerns being resolved by SMA
  - ii. JAN delivery:
    - contractor working toward substantial completion
    - JAN has work to complete on termination location in order to receive Cutter Lateral Water
    - Late 2023 may see some demands from the water system but more likely more in the future
    - 2023 Cutter will be able to deliver water to JAN
  - iii. Water treatment and conveyance contract being negotiated with JAN with primary focus on fixed and variable costs where some language may be updated from what was previously discussed
- c. Reach 21 Booster Plant
  - i. Reclamation working toward 30% design in April
  - ii. VE expected end of May
  - iii. May need additional ROW
- d. Area-Wide Optimization Program (Reclamation)
  - i. Continue to relay data to the State

  - a. SJL Disinfection By-Product Study Update
    - i. Gallup to request information regarding contact time for blending well water and needs the information for PP8 specifically as well as others
    - ii. Study is ongoing. Tank aeriation study should be complete by April with larger DBP study across the SJL ongoing.
  - b. Corrosion Control Study
    - i. Study is ongoing.
- 22) San Juan Lateral Water Treatment Plant (Reclamation)
  - a. Appraisal Level Design Update
    - i. Appraisal level design estimate will be reviewed with stakeholders following this meeting.
  - b. UF/NF Membranes Pilot Study
    - i. Some data has been received and shared with potential offerors for the SJLWTP.
    - ii. Some of the equipment on the skid suffered freeze damage and is being repaired.
  - c. Solicitation Schedule/TPEC
    - i. Mar 1 RFO
    - ii. TPEC slots are available for Navajo Nation, NTUA, and City of Gallup
      - NM does not feel they need to be part of the selection process
    - iii. TPEC expected last two weeks of April
    - iv. RFP TPEC in Feb/Mar 2024 and include same members from TPEC
