





Latest Construction Contract Awarded on NGWSP

On September 12, 2019, the Bureau of Reclamation awarded the latest section of the NGWSP, Block 4C-8, to Oscar Renda Contracting, Inc., of Roanoke, Texas, for \$83.7 million. This section of the project will include construction of nearly 30 miles of 48-inch and 42-inch diameter pipeline spanning from the Navajo communities of Little Water to Naschitti, New Mexico.

“This award continues our important work to develop and modernize water infrastructure, honor the Department’s federal Indian trust responsibility and strengthen partnerships with tribal and local communities,” said Department of the Interior Secretary David Bernhardt. Reclamation Commissioner Brenda Burman added, “Completing the Navajo-Gallup Water Supply Project is a key priority for Reclamation as we work to improve water supplies for tribal and rural communities.”

“The Navajo-Gallup Water Supply Project will be trans-formative for communities in the Navajo Nation, the Jicarilla Apache Nation, and Gallup. Over the last decade, I’ve been proud to fight for the major federal investments necessary to finally deliver long-term clean drinking water supplies to thousands of families throughout northwestern New Mexico,” said Senator Martin Heinrich (D-NM). “The construction of this major project is also creating jobs and promoting economic development throughout the

region. I will continue working to uphold the federal commitments in the historic Navajo Nation Water Rights Settlement Agreement and ensure that our communities in Indian Country have the resources they need to thrive.”

Work under this contract will begin in January 2020 and is expected to last for approximately 2 years. Construction will be visible from U.S. Highway 491.

Navajo-Gallup on the World Stage

Representatives from the Department of the Interior and the Navajo Nation recently traveled to Sweden to participate in the Stockholm International Water Institutes's World Water Week. The annual event, which attracted over 4,000 participants from 138 countries was held August 25-30, 2019. The Navajo-Gallup Water Supply Project was the subject of one of the 277 sessions at the conference. The NGWSP delegation presented an overview of Indian Water Rights Settlements in general, and the Navajo-San Juan NM Settlement in particular, with a focus on the NGWSP. The theme for this year's conference was "Water for Society: Including All" and many sessions focused on water issues that indigenous people throughout the world are facing. It was surprising to many attendees to learn that Native Americans in the United States are confronted with similar water access and shortage issues. It was notable however that several of those that attended the NGWSP presentation expressed admiration and praise for the great progress that has been made on the project that, as soon as 2020, will bring clean, wet water to portions of the Navajo and Jicarilla Apache Reservations. The trip was sponsored by Reclamation's Native American and International Affairs Program.
