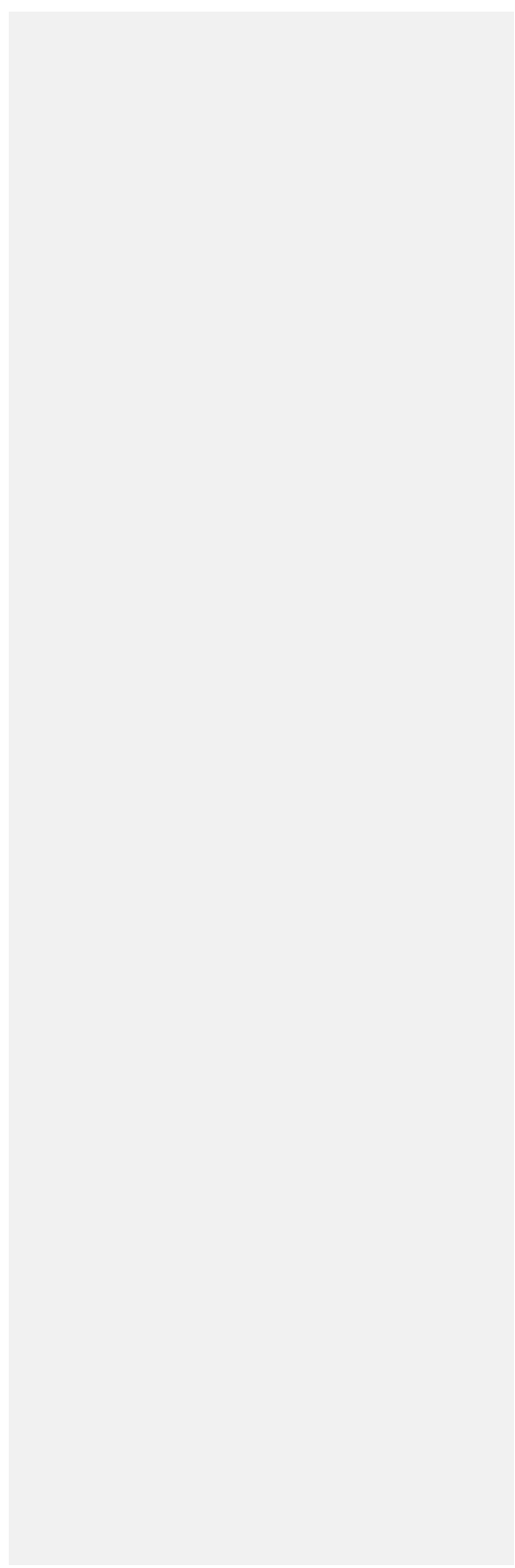

12 THE UTE MOUNTAIN UTE TRIBE

15 THIS REPAYMENT CONTRACT (Contract), entered into this _____ day of
16 _____, 201_, pursuant to the Act of Congress approved June 17, 1902 (32 Stat.
17 388), and acts amendatory thereof or supplementary thereto, all of which acts are commonly
18 known and referred to as the Federal Reclamation Laws, between the UNITED STATES OF
19 AMERICA, hereinafter referred to as the United States, represented by the officer executing this
20 Contract, and THE UTE MOUNTAIN UTE TRIBE, hereinafter referred to as the Tribe,
21 (individually as "Party" and collectively as "the Parties" to this Contract) acting through their
22 representatives.

23 WITNESSETH, That:

24 WHEREAS, the following statements are made in explanation:

25 (a) The Act of Congress approved April 11, 1956 (70 Stat. 105), authorized the planning
26 and investigation of the Animas-La Plata Project (Project), as a participating project of the
27 Colorado River Storage Project; subsequently, the construction, operation, and maintenance of
28 the Animas-La Plata Project was authorized by Title V of the Colorado River Basin Project Act
29 of September 30, 1968 (82 Stat. 896), and the United States has investigated, planned, and
30 constructed the said Project for the diversion, storage, salvage, and delivery of the waters of the
31 Animas River, which the Project has among its authorized purposes the furnishing of water for
32 municipal, industrial, domestic, and other beneficial purposes. The water rights settlement
33 purposes of the Project were authorized by the Colorado Ute Indian Water Rights Settlement Act
34 of 1988, Public Law 100-585 (102 Stat. 2973), as amended by the Colorado Ute Settlement Act

1 Amendments of 2000, Public Law 106-554 (114 Stat. 2763) (hereinafter referred to as the
2 Settlement Act).

3 (b) The Settlement Act authorized the Secretary to settle the outstanding claims of the Tribe
4 on the Animas and La Plata Rivers, acting through the Bureau of Reclamation (Reclamation) to
5 complete construction of, and operate and maintain Project Works with sufficient capacity to
6 divert and store, and use water from the Animas River to provide for an average annual depletion
7 of 57,100 acre-feet of water to be used for a municipal and industrial (M&I) water supply.

8 (c) Pursuant to the Settlement Act, the United States agrees to deliver through the use of
9 Project Works, or make available for delivery to the Tribe, an M&I water allocation with an
10 average annual depletion not to exceed 16,525 acre-feet for its present and future needs.

11 (d) The Secretary has determined in accordance with Section 6(a)(2) of the Settlement Act,
12 the Tribe's construction costs allocable to the Project Works that are required to deliver the
13 Tribe's Statutory Water Allocation shall be nonreimbursable to the United States.

14 (e) Reclamation has completed the Animas-La Plata Final Supplemental Environmental
15 Impact Statement (FSEIS) dated July 2000, and subsequent Record of Decision (ROD) dated
16 September 25, 2000, for compliance with the National Environmental Policy Act. The Tribe
17 acknowledges that as a result of this regulatory compliance, and the terms of this Contract, it is
18 limited in this Contract to an M&I water allocation with an average annual depletion not to
19 exceed 16,525 acre-feet of water.

20 (f) Water rights for the Project have been obtained in Colorado and New Mexico.

21 (g) The Tribe has an interest in contracting for the water supply allocated to the Ute
22 Mountain Ute Tribe pursuant to the Settlement Act.

23 (h) The Tribe has demonstrated its legal and financial capability to make the contributions
24 and payments required by this Contract.

25 (i) The Project will be used to provide a dependable long-term supply of M&I water and
26 water storage for the Tribe as described in the FSEIS and the ROD.

27 (j) It is the intent of both Parties that any rights granted by this Contract are not limited to a
28 specific term, but would instead continue in full force and effect pursuant to Section 9(c)(1) of
29 the Reclamation Project Act of 1939, 43 U.S.C. § 485h. This Contract will remain in full force
30 and effect for the useful Project life, or until mutually agreed upon by the Parties.

1 (k) The Tribe concurs with the method of payment in which the Secretary shall pay,
2 directly to the Project Operator, the Tribe's pro-rata portion of the unused fixed annual operation,
3 maintenance, and replacement (OM&R) costs, pursuant to Section 6 (a)(4)(A) of the Settlement
4 Act. The parties acknowledge that the Settlement Act provides that construction costs allocable
5 to the Project Works are nonreimbursable to the United States.

6 (l) The construction of the Project Works, the allocation of the water supply from those
7 facilities to the Colorado Ute Tribes, the provision of funds to the Colorado Ute Tribes, and the
8 issuance of an amended final consent decree by the State of Colorado, as contemplated in the
9 Settlement Act, shall constitute final settlement of the Colorado Ute Tribe claims to water rights
10 on the Animas and La Plata Rivers in the State of Colorado.

11 (m) The Parties hereto desire to enter into this Contract in order to secure this M&I water
12 supply pursuant to the terms and conditions of the Settlement Act for the use of such water in
13 and for the benefit of the Tribe as hereinafter provided.

14
15 NOW, THEREFORE, in consideration of the mutual and dependent covenants and
16 conditions contained herein, the Parties hereto agree as to the following:

17
18 1. GENERAL DEFINITIONS

19 For the purposes of this Contract only, unless otherwise distinctly expressed or manifestly
20 incompatible with the intent hereof, the term:

21 (a) "Appurtenant Facilities" includes, but is not limited to, transmission lines, roads,
22 buildings, and other facilities related to the Project Works constructed as a part of the Project.

23 (b) "Association" means the Animas-La Plata Operations, Maintenance, and Replacement
24 Association, established by the Project sponsors who are signatories to the Intergovernmental
25 Agreement (IGA) dated March 4, 2009, pursuant to the Colorado Uniform Unincorporated
26 Nonprofit Association Act, 7-30-101 et seq., CRS (2006), to carry out the OM&R activities and
27 responsibilities of the Project.

28 (c) "Average Annual Depletion" means the depletion of Project Water accounted for over an
29 interval of time as a whole or by an individual Project participant, pursuant to the Settlement Act,
30 to be determined by the United States in cooperation with Project participants.

1 (d) "Colorado Ute Tribes" means the Ute Mountain Ute Tribe, and the Southern Ute Indian
2 Tribe, both federally recognized Indian tribes.

3 (e) "Consultation" or "consult" refers to an ongoing obligation of both parties to implement
4 the provisions of this Contract with a full exchange of information so as to assure that each party
5 is provided full participation in the decision making process. Consultation shall be required of
6 each party with respect to each section of the Contract regardless of whether the section itself
7 sets forth a Consultation requirement. The Consultation required shall be reasonable under the
8 circumstances, and except in exigent circumstances, Consultation shall be undertaken in advance
9 of decision making. In the event that agreement cannot be reached and the United States makes
10 a decision, appeals are available to the extent allowed under applicable laws.

11 (f) "Contracting Officer" or "Secretary" or "United States" means the Secretary of the
12 United States, Department of the Interior or her/his duly authorized representative to administer
13 this Contract.

14 (g) "First Use" means the date in which water is first used by the Tribe or used pursuant to a
15 Third-Party Contract with the Tribe. First Use of water shall be deemed to occur in any water
16 year in which the Tribe actually ~~takes delivery of uses Project -w~~Water or when a third party
17 pays the Tribe ~~under the terms of the Third Party Contract~~ or accepts delivery of water under the
18 terms of the Third Party Contract. A Third-Party Contract pursuant to which the only income to
19 the Tribe is in the nature of a standby charge is deemed not to be a first use of water. The
20 Tribe's First Use shall not be triggered when a portion of its Statutory Water Allocation is used
21 for emergency purposes, including, fire, contamination of the water in the Animas River or in
22 Lake Nighthorse, or as otherwise approved by Reclamation. Releases made at the direction of
23 the Secretary for the purposes of drought response, compact compliance, or as provided in
24 federal legislation shall not be considered First Use, provided the Tribe does not receive
25 compensation for such uses. Use of joint pool by others, as provided in Exhibit A of the IGA, is
26 not to be considered as First Use, provided the Tribe does not receive compensation for such use,
27 beyond that identified in Exhibit A of the IGA. However, use of the Tribe's water by another
28 Project participant as provided in 4.08 of Exhibit A of the IGA shall be considered First Use.

29 (h) "Fixed OM&R Costs" includes, but ~~is-are~~ not limited to costs of labor, materials and
30 equipment required to maintain Project Works; Project administration and overhead; energy

1 consumption and power demand costs attributable to the pumping of water to Lake Nighthorse to
2 account for testing; evaporation and seepage losses; and annual payments to reserve fund(s).

3 (i) "IGA" means the intergovernmental agreement, effective March 4, 2009, which has been
4 executed by and among the Colorado Water Resource and Power Development Authority; the
5 San Juan Water Commission, a political subdivision of the state of New Mexico; the La Plata
6 Conservancy District, a political subdivision of the state of New Mexico; the Southern Ute
7 Indian Tribe, a federally recognized Indian tribe; the Navajo Nation, a federally recognized
8 Indian tribe; and the Ute Mountain Ute Tribe, a federally recognized Indian tribe; and their
9 authorized assignees, that have been identified by the Settlement Act to receive a water
10 allocation that established the Association to carry out OM&R activities and responsibilities of
11 the Project.

12 (j) "Operation and Maintenance Facilities" means those facilities necessary to support
13 OM&R obligations, including a permanent operating facility with associated office space,
14 shop(s) for repair and housing of the maintenance support equipment, storage place for supplies,
15 and equipment yard.

16 (k) "Point of Delivery" means the point where the water is released at the outlet works of
17 Ridges Basin Dam or bypassed at the Durango Pumping Plant, or other location where water is
18 diverted directly from Lake Nighthorse and/or in the Animas River below the Durango Pumping
19 Plant.

20 (l) "Project Operator" means the Association, pursuant to Operation, Maintenance, and
21 Replacement Contract No. 10-WC-40-370, or the United States.

22 (m) "Project Storage Water" means Project Water ~~provided from stored age~~ in Lake
23 Nighthorse, the storage component of the Project.

24 (n) "Project Water" means all water released from storage through the Animas-La Plata
25 Project, or bypassed and measured from the natural flow of the Animas River, at the Durango
26 Pumping Plant, as part of the Project participant's statutory water allocation.

27 (o) "Project Works" means all works or facilities as described in the Settlement Act,
28 including a reservoir, a pumping plant, a reservoir inlet conduit, and Appurtenant Facilities, not
29 including recreation facilities, with sufficient capacity to divert and store water from the Animas
30 River for an average annual depletion of 57,100 acre-feet of water to be used for an M&I water

1 supply, together with lands and rights-of-way for such works, as described in Article 2.

2 (p) “Settlement Act” means the Colorado Ute Indian Water Rights Settlement Act of 1988,
3 Public Law 100-585 (102 Stat. 2973), as amended by the Colorado Ute Settlement Act
4 Amendments of 2000, Public Law 106-554 (114 Stat. 2763), the Energy and Water Development
5 Appropriations Act of 2006, Public Law 109-103 (119 Stat. 2268), and the Consolidated
6 Appropriations Act of 2008, Public Law 110-161 (121 Stat. 2123).

7 (q) “Third-Party Contract” means any contract entered into between the Tribe and a third
8 party for the beneficial use of the Tribe’s Statutory Water Allocation.

9 (r) “Tribe” or “Tribal” means the Ute Mountain Ute Tribe of the Ute Mountain Ute
10 Reservation, headquartered in Towaoc, Colorado, a body politic and federally recognized Indian
11 Tribe as provided in Section 104 of the Act of November 2, 1994 (Pub. L. 103-454; 108 Stat.
12 4791, 4792).

13 (s) “Tribe’s Statutory Water Allocation” means the M&I water allocation with an average
14 annual depletion not to exceed 16,525 acre-feet of water, pursuant to Section 6(a)(1)(A)(ii)(II) of
15 the Settlement Act.

16 ~~(s)~~(t) “Use” of water is as defined pursuant to Section 6(e) of the Settlement Act.

17 ~~(s)~~(u) “Variable OM&R Costs” are the costs of power including energy consumption
18 and that share of power demand costs for the pumping of water not designated as Fixed OM&R
19 costs.

21 2. PROJECT WORKS

22 Subject to the terms and conditions of this and other applicable contracts related specifically to
23 this Project, the United States has constructed the Project Works and Appurtenant Facilities,
24 acquired lands, and provided certain moveable property and equipment to the Project Operator
25 needed to carry out OM&R activities and responsibilities as necessary for Project purposes.

26 (a) The Project Works are presently identified as the following:

27 (1) Ridges Basin Dam and Lake Nighthorse are located on Basin Creek approximately 3
28 miles southwest of Durango, Colorado. The reservoir has a total storage capacity of
29 123,541 acre-feet.

30 (2) Durango Pumping Plant is located adjacent to the Animas River ~~and which~~ pumps

2 (3) Ridges Basin Inlet Conduit extends from the Durango Pumping Plant to Lake
3 Nighthorse.

4 (4) Operation and Maintenance Facilities have been constructed, as determined necessary
5 by the United States, for the required OM&R of Project Works.

6 (b) The United States, after Consultation with the Tribe, shall have the right at any time to
7 increase the capacity of the Project Works, or any unit or feature thereof, for other than currently
8 authorized project purposes without additional capital or OM&R costs to the Tribe; provided,
9 that the Tribe's use of the Tribe's Statutory Water Allocation shall not be impaired thereby. The
10 right of use of such increased capacity is reserved to the United States.

11 (c) Any additions, changes to, or operation of Project Works or changes in use of the Tribe's
12 Statutory Water Allocation from that stated in the FSEIS, and subsequent ROD, will, if required
13 by law, be subject to further compliance with applicable environmental statutes, which shall
14 include an analysis of potential impacts on other Project participants.

15
16
17 3. WATER DELIVERY PROVISIONS

18 (a) Pursuant to the Settlement Act, the United States agrees to deliver or make available for
19 delivery to the Tribe an M&I water allocation with an average annual depletion not to exceed
20 16,525 acre-feet from the Project. The water released or bypassed for the Tribe pursuant to this
21 Contract, or a third party pursuant to a Third-Party Contract, as provided by Article 9 shall be
22 measured **by the Project Operator** at the outlet works of Ridges Basin Dam, and/or in the Animas
23 River below the Durango Pumping Plant, with measuring facilities installed by the United States
24 as a part of the Project. The Tribe may take its water from additional points of diversion directly
25 from Lake Nighthorse after Consultation and approval of the United States. Water delivered at
26 these additional points of diversion on Lake Nighthorse shall be measured at those points of
27 diversion by facilities provided by the Tribe or its third party contractors. Water will be
28 available at the outlet works of Ridges Basin Dam, additional points of diversion on Lake
29 Nighthorse and/or the Animas River in such quantities as the Tribe determines, subject to

3 ~~(a)~~(b) Project Water shall remain subject to the authority of the United States
4 ~~(b)~~(c) Once water is released from the outlet works of Ridges Basin Dam, bypassed at
5 the Durango Pumping Plant, or diverted from Lake Nighthorse, the United States will not be
6 responsible for the control, carriage, handling, use, disposal, or distribution of the Tribe's
7 Statutory Water Allocation, or for any damage of any nature whatsoever arising out of or
8 connected to the control, carriage, handling, transportation loss, treatment, use, disposal of the
9 Tribe's Statutory Water Allocation, except when caused by the direct action of the United States.

10 ~~(e)~~(d) All facilities required for taking the water furnished under this Contract from the
11 points of delivery, and putting it to use by the Tribe and its users or Third-Party Contractors will
12 be acquired, constructed or installed, and operated and maintained by the Tribe, its users, or
13 Third Party Contractors at their sole expense, unless otherwise agreed to by the United States.
14

15 4. ALLOCATION AND USE OF PROJECT WATER

16 (a) The Tribe's Statutory Water Allocation consists of a combination of direct diversion
17 from the natural flows from the Animas River, and/or water released from storage to Basin Creek
18 and subsequently diverted from the Animas River, and/or water released to non-project facilities.

19 (b) The Tribe shall have the right of up to 38,108.5 acre-feet of storage capacity in Lake
20 Nighthorse to supplement the amount of direct flow diversion as necessary to fulfill the Tribe's
21 Statutory Water Allocation. Unless the IGA is in effect, any portion of the 38,108.5 acre-feet of
22 the unused storage shall be retained in Lake Nighthorse, and shall be available for the Tribe's use
23 in succeeding years. The Tribe shall not purchase excess Project Water from other Project
24 participants until Full Use of the Tribe's Statutory Water Allocation, unless approved by
25 Reclamation.

26 (c) If required to ensure that the Tribe's Statutory Water Allocation with an average annual
27 depletion not to exceed 16,525 acre-feet of water is met, the water may be used and reused to the
28 extent permitted by the Project water right decrees and Federal authorizations. In addition, the
29 water may be used at any location in the State of Colorado, in accordance with all applicable

6 subcontractors or assignees, to provide appropriate means for access to land needed for delivery
7 of Project Water through non-project facilities.

9 5. LIMITED RESPONSIBILITY FOR DISTRIBUTION

10 Upon delivery, as specified under Article 3 herein, the Tribe shall hold the United States,
11 its officers, agents, employees, and successors or assigns, harmless from every claim for
12 damages to persons or property, direct or indirect, and of whatever nature, arising out of or in
13 any manner connected with the control, carriage, handling, distribution or use of such water
14 beyond the Point of Delivery.

15 6. TRUST RESPONSIBILITIES

16 Nothing in this Contract diminishes the obligations of the United States pursuant to the
17 Settlement Act.

18 7. WATER RIGHT PROVISIONS

19 (a) The Tribe, or its assignee, shall protect its interest in the Project water rights, and in
20 case a dispute arises as to the character, extent, priority or validity of the rights of the United
21 States, or the Tribe to use or permit use of Project Water, the Tribe shall promptly bring and
22 diligently prosecute and/or defend judicial proceedings for the determination of such dispute, and
23 shall take all other measures necessary toward the defense and protection of the Project water
24 supply. The United States will continue to defend such rights pursuant to the tribal decrees
25 (Case # W-1603-76).

27 8. PROCEDURE TO INITIATE PROJECT WATER DELIVERY

28 (a) Effective upon the date of execution of this Contract, the Tribe's Statutory Water
29 Allocation shall be available for beneficial use by the Tribe upon their request for Project Water

1 delivery, as provided herein. The initial request by the Tribe for any new delivery of a specified
2 quantity of Project Water (rounded to the nearest acre-foot) shall be conducted in the following
3 two ways:

4 (1) Delivery of the Tribe's Statutory Water Allocation to the Tribe, for use by the Tribe,
5 shall be accomplished through written notice to Reclamation, pursuant to Article 17, and
6 the Project Operator. The written notice shall include the quantity of water to be diverted,
7 a description of the use, the location of the diversion point(s), and the estimated depletion
8 amount of the Tribe's Statutory Water Allocation. The date the water is taken at a Point
9 of Delivery will establish the date of First Use by the Tribe of that portion of the Tribe's
10 Statutory Water Allocation as stipulated under Section 6(a)(4)(A) of the Settlement Act.

11 (2) Delivery of the Tribe's Statutory Water Allocation under Third-Party Contracts shall
12 be accomplished as provided under Article 9. The date upon which a third party pays the
13 Tribe under the terms of the **Third-Party Contract for delivery of water, whether or not the**
14 **third party takes delivery,** will establish the date of First Use by the Tribe of that portion
15 of the Tribe's Statutory Water Allocation as stipulated under Section 6(a)(4)(A) of the
16 Settlement Act.

17 (b) The Tribe's Statutory Water Allocation associated with all the Project Water deliveries
18 shall be **measured** and delivered pursuant to Articles 3 and 4.

19
20 9. THIRD-PARTY CONTRACTS

21 (a) Any contract entered into between the Tribe and any third party for the beneficial use of
22 the Tribe's Statutory Water Allocation under this Contract shall be subject to written approval by
23 the United States. United States' approval will be based on a determination that the Third-Party
24 Contract will not negatively affect Project operations, benefits, or authorized purposes, and is
25 consistent with applicable federal law and commitments. Nothing in these Third-Party Contracts
26 shall interfere with other contractual, legal, or regulatory obligations of the United States. The
27 Third-Party Contract will require the third-party to be bound to the provisions of this Contract
28 including, but not be limited to, terms of measurement, operations, environmental compliance,
29 and the impact of defaults on Project Works.

30 (b) The Third-Party Contract will state the total amount of water to be diverted, description

1 of use, location of diversion point(s) of water, the initial estimated depletion amount, any amount
2 of water under terms of a standby option, and the water delivery schedule, all consistent with the
3 Average Annual Depletion.

4 (c) Approval by the United States shall not be unreasonably withheld. The United States
5 shall have 60 days after receipt of the proposed Third-Party Contract to inform the Tribe of its
6 approval or denial of the Third-Party Contract. If additional environmental compliance is
7 required, the Tribe and the United States will develop a schedule for approval. Water made
8 available under Third-Party Contracts shall be delivered from the Tribe's Statutory Water
9 Allocation. The Tribe will be the responsible party to pay the applicable share of the OM&R
10 costs of the contracted water to the Project Operator.

11

12 10. CONSTRUCTION CHARGE OBLIGATION

13 Pursuant to Sections 6(a)(2) of the Settlement Act, all construction and all interest costs
14 allocated to the Tribe's Statutory Water Allocation are declared non-reimbursable and hereby
15 waived.

16 11. COST PROVISIONS

17 (a) Pursuant to Section 6(a)(4)(A) of the Settlement Act, and with respect to the Tribe's
18 Statutory Water Allocation, until that water is put to First Use the Secretary shall pay the annual
19 Fixed OM&R Costs allocable to The Tribe's M&I water allocation in accordance with the
20 Settlement Act.

21 (b) Pursuant to Section 6(a)(5)(B) of the Settlement Act, upon the Tribe's First Use of an
22 increment of the Tribe's Statutory Water Allocation as provided under Articles 8 and 9, the Tribe
23 shall bear all Variable OM&R costs associated with all increments of water established under
24 First Use, and the pro rata share of all annual Fixed OM&R costs of such increments from that
25 point in time on, throughout the life of the Project. The pro rata share of the Tribe's total annual
26 Fixed OM&R Costs to be borne by the Tribe will be based upon the formula:

28 Pro Rata Share of Total = $\frac{\text{Accumulated Increments Established Under First Use}}{\text{Statutory Water Allocation}}$
29 Tribal Fixed OM&R Obligation

30

1 (c) During the period in which the Secretary is paying any portion of the Tribe's Fixed
2 OM&R costs, Reclamation, in conjunction with the three-year and one-year OM&R work plans
3 required under its OM&R Contract with the Association, will confer with the Tribe.

4 Reclamation will continue to confer with the Tribe on the Association's annual OM&R budget
5 until the Tribe has assumed the responsibility to pay 100 percent of its OM&R costs.

6 (d) As long as the IGA is in effect, the Tribe and the Secretary shall follow the terms and
7 conditions set forth in the IGA. The Secretary shall pay the Tribe's share of Fixed OM&R costs
8 for the Tribe's water not established under First Use in accordance with the procedures set forth
9 by the Association. The Tribe's share of Fixed OM&R Costs of the multipurpose facilities, as
10 identified in the IGA, is 35.5% of the total Fixed OM&R Costs for the Project Works. The
11 Tribe's share of Variable OM&R Costs include actual costs of replacing Project Storage Water
12 released or diverted from Lake Nighthorse by request of the Tribe, or any Third Party
13 Contractor.

14 (e) In the unlikely event that the IGA is voided or otherwise terminated, the OM&R costs
15 allocated to the Tribe will be comprised of the Tribe's share of Fixed OM&R Costs, as defined
16 by the final cost allocation, and the Tribe's share of Variable OM&R Costs. The procedures for
17 the payment to the Project Operator of the Tribe's OM&R obligation by the Secretary for the
18 Tribe's Statutory Water Allocation not established under First Use, and by the Tribe for the
19 Tribe's Statutory Water Allocation established under First Use are as follows:

- 20 (1) The Tribe's share of Fixed OM&R costs will be established by the final cost
21 allocation for the Project which will base that share on a proration of the Tribe's
22 38,108.5 acre-feet of storage capacity to the total active capacity of 95,030 acre-
23 feet;
24
- 25 (2) The Tribe's share of Variable OM&R costs include actual costs of replacing
26 Project Storage Water released or diverted from Lake Nighthorse by request of
27 the Tribe, or any Third Party Contractor.
- 28 (3) The Tribe under this Contract shall have 38,108.5 acre-feet of storage capacity
29 allocated for its exclusive use in Lake Nighthorse annually to the extent that
30 water stored in the Tribe's storage capacity space may be held for exclusive

1 delivery to the Tribe in future years as necessary to meet the delivery demands of
2 the Tribe and to support use of the Project Water supply, in accordance with
3 Article 3(a). The Project Operator shall fill and refill the Tribe's storage capacity
4 space as often as direct flow is legally available from the Animas River to fill
5 said space under the Project diversion right issued in the State of Colorado, or as
6 free river conditions allow. The Project participants recognize, however, that at
7 times it may be preferable to delay pumping water to replace the Project water
8 supply in ~~the Reservoir~~Lake Nighthorse until power costs are less expensive and
9 thus that the ~~Reservoir~~Lake Nighthorse may not be full at all times.

10 (4) An OM&R charge notice shall be furnished annually by the Project Operator, in
11 advance, to the Secretary and the Tribe stating the Tribe's share of OM&R costs
12 associated with said Project Works.

13 (5) Payment will be made to the Project Operator, within a reasonable amount of
14 time, in advance, for the Tribe's share of the OM&R costs associated with said
15 Project Works.

16 (f) It is the intent of both parties that the Tribe will pay its obligations under this Contract
17 and the Tribe agrees to take all reasonable actions to ensure adequate funds are available to pay
18 the amounts as required under this Article. In the event that the Tribe demonstrates to the
19 Secretary that it is unable to pay in whole or in part its Project OM&R obligations from the gross
20 revenues which could be generated from a Third-Party Contract for the use of its water, pursuant
21 to Section 6(d) of the Settlement Act, then the Secretary will bear those obligations to the Project
22 Operator on behalf of the Tribe, subject to Congressional appropriations.

23
24 12. WATER SUPPLY SHORTAGE

25 (a) With respect to water made available from the Project under the terms of this Contract,
26 the Tribe shall share proportionally in any water shortages to the Project, consistent with all
27 applicable law.

28 (b) When the IGA is not in effect, in any year in which there may occur a shortage from any
29 cause, the United States reserves the right to apportion the available water allocation pursuant to
30 the Settlement Act, as amended, and applicable laws, including the Animas-La Plata Project

1 Compact, among the Tribe and others entitled to receive water from the Project in accordance
2 with determinations of the Contracting Officer.

3

4 13. TITLE TO PROJECT

5 Title to the Project Works shall be held by the United States, unless specifically provided
6 otherwise by Congress, notwithstanding transfer of the OM&R of any said works to the Project
7 Operator.

8

9 14. SEVERABILITY

10 If any provisions of this Contract shall, for any reason be determined to be illegal or
11 unenforceable, the Parties, nevertheless, intend that the remainder of this Contract shall remain in
12 full force and effect. Furthermore, any adjustments or variations to this Contract necessitated by
13 future negotiations with other Project beneficiaries can be accomplished by amending this
14 Contract. In the event that unforeseen issues arise, the Tribe and the United States will work
15 together to attempt to resolve the issue by either amending this Contract, entering into a
16 memorandum of understanding or other appropriate means.

3 18. CONTINGENT ON APPROPRIATION OR ALLOTMENT OF FUNDS

4
5 The expenditure or advance of any money or the performance of any obligation of the
6 United States under this contract shall be contingent upon appropriation or allotment of funds.
7 Absence of appropriation or allotment of funds shall not relieve the Tribe from any obligations
8 under this contract. No liability shall accrue to the United States in case funds are not
9 appropriated or allotted.

10
11 19. OFFICIALS NOT TO BENEFIT

12
13 No Member of or Delegate to the Congress, Resident Commissioner, or official of the
14 Tribe shall benefit from this contract other than as a water user or landowner in the same manner
15 as other water users or landowners.

16
17 20. ASSIGNMENT LIMITED – SUCCESSORS AND ASSIGNS OBLIGATED

18
19 The provisions of this contract shall apply to and bind the successors and assigns of the
20 parties hereto, but no assignment or transfer of this contract or any right or interest therein by
21 either party shall be valid until approved in writing by the other party.

22
23 21. BOOKS, RECORDS, AND REPORTS

24
25 The Secretary and the Tribe shall jointly establish and maintain accounts and other books
26 and records pertaining to administration of the terms and conditions of this contract as are
27 necessary to operate the subject facilities, including the Tribe's financial transactions; water
28 supply data; project operation, maintenance, and replacement logs; and other matters that the
29 Contracting Officer may require as it pertains to the obligations under this contract. Reports
30 shall be furnished to the Contracting Officer in such form and on such date or dates as the
31 Contracting Officer may require. Subject to applicable Federal laws and regulations, each party
32 to this contract shall have the right during office hours to examine and make copies of the other
33 party's books and records relating to matters covered by this contract.

34
35 22. RULES, REGULATIONS, AND DETERMINATIONS

36
37 (a) The parties agree that the delivery of water or the use of Federal facilities pursuant to
38 this contract is subject to Federal reclamation law, as amended and supplemented, and the rules
39 and regulations promulgated by the Secretary of the Interior under Federal reclamation law.

40 (b) The Contracting Officer shall have the right to make determinations necessary to
41 administer this contract that are consistent with its provisions, the laws of the United States and
42 the state of Colorado, and the rules and regulations promulgated by the Secretary of the Interior.
43 Such determinations shall be made in Consultation with the Tribe.

1 23. PROTECTION OF WATER AND AIR QUALITY

2
3 (a) Project facilities used to make available and deliver water to the Tribe shall be operated
4 and maintained in the most practical manner to maintain the quality of the water at the highest
5 level possible as determined by the Contracting Officer: *Provided, That* the United States does
6 not warrant the quality of the water delivered to the Tribe and is under no obligation to furnish or
7 construct water treatment facilities to maintain or improve the quality of water delivered to the
8 Tribe.

9 (b) The Tribe shall comply with all applicable water and air pollution laws and regulations
10 of the United States and the state of Colorado; and shall obtain all required permits or licenses
11 from the appropriate federal [, state, or local] authorities necessary for the delivery of water by
12 the Tribe; and shall be responsible for compliance with all applicable federal, state, and local
13 water quality standards applicable to surface and subsurface drainage and/or discharges
14 generated through the use of Federal or Tribe facilities or project water provided by the Tribe
15 within the Tribe's Project Water Service Area.

16 (c) This article shall not affect or alter any legal obligations of the Secretary to provide
17 drainage or other discharge services.

18
19 24. WATER CONSERVATION

20
21 Prior to the delivery of water provided from or conveyed through federally constructed or
22 federally financed facilities pursuant to this contract, the Tribe shall develop a water
23 conservation plan, which shall contain definite water conservation objectives, appropriate
24 economically feasible water conservation measures, and time schedules for meeting those
25 objectives.

26
27 25. INDIAN EMPLOYMENT – EQUAL EMPLOYMENT OPPORTUNITY

28
29 (a) The Tribe shall give preference in employment to Indians in accordance with applicable
30 law. The Bureau of Indian Affairs Office of Employment Assistance shall be notified of
31 employment opportunities 48 hours before any positions are advertised to the general public.

32 (b) Except as provided above, in the course of performing this contract, the Tribe agrees as
33 follows:

34 (1) The Tribe will not discriminate against any employee or applicant for employment
35 because of race, color, religion, sex, disability, or national origin. The Tribe will take
36 affirmative action to ensure that applicants are employed, and that employees are treated
37 during employment, without regard to their race, color, religion, sex, disability, or
38 national origin. Such action shall include, but not be limited to the following:
39 employment, upgrading, demotion, or transfer; recruitment or recruitment advertising;
40 layoff or termination; rates of pay or other forms of compensation; and selection for
41 training, including apprenticeship. The Tribe agrees to post in conspicuous places,
42 available to employees and applicants for employment, notices to be provided by the
43 Contracting Officer setting forth the provisions of this nondiscrimination clause.

44 (2) The Tribe will, in all solicitations or advertisements for employees placed by or on

1 behalf of the Tribe; state that all qualified applicants will receive consideration for
2 employment without regard to race, color, religion, sex, disability, or national origin.

3 (3) The Tribe will send to each labor union or representative of workers with which it
4 has a collective bargaining agreement or other contract or understanding, a notice, to be
5 provided by the Contracting Officer, advising the labor union or workers' representative
6 of the Tribe's commitments under section 202 of Executive Order 11246 of September
7 24, 1965 (EO 11246), and shall post copies of the notice in conspicuous places available
8 to employees and applicants for employment.

9 (4) The Tribe will comply with all provisions of EO 11246, and of the rules,
10 regulations, and relevant orders of the Secretary of Labor.

11 (5) The Tribe will furnish all information and reports required by EO 11246, and by the
12 rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will
13 permit access to his books, records, and accounts by the Contracting Agency and the
14 Secretary of Labor for purposes of investigation to ascertain compliance with such rules,
15 regulations, and orders.

16 (6) In the event of the Tribe's noncompliance with the nondiscrimination clauses of this
17 contract or with any of such rules, regulations, or orders, this contract may be canceled,
18 terminated or suspended in whole or in part and the Tribe may be declared ineligible for
19 further Government contracts in accordance with procedures authorized in EO 11246,
20 and such other sanctions may be imposed and remedies invoked as provided in EO 11246
21 or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.

22 (7) The Tribe will include the provisions of paragraphs (1) through (7) in every
23 subcontract or purchase order unless exempted by the rules, regulations, or orders of the
24 Secretary of Labor issued pursuant to section 204 of EO 11246, so that such provisions
25 will be binding upon each subcontractor or vendor. The Tribe will take such action with
26 respect to any subcontract or purchase order as may be directed by the Secretary of Labor
27 as a means of enforcing such provisions, including sanctions for
28 noncompliance: *Provided, however*, that in the event the Tribe becomes involved in, or
29 is threatened with, litigation with a subcontractor or vendor as a result of such direction,
30 the Tribe may request that the United States enter into such litigation to protect the
31 interests of the United States.

32
33 26. COMPLIANCE WITH CIVIL RIGHTS LAWS AND REGULATIONS

34
35 (a) The Tribe shall comply to the extent applicable with Title VI of the Civil Rights Act of
36 1964 (Pub. L. 88-352; 42 U.S.C. § 2000d), the Rehabilitation Act of 1973 (Pub. L. 93-112,
37 Title V, as amended; 29 U.S.C. § 791, et seq.), the Age Discrimination Act of 1975 (Pub. L. 94-
38 135, Title III; 42 U.S.C. § 6101, et seq.), [Title II of the Americans with Disabilities Act of
39 1990 (Pub. L. 101-336; 42 U.S.C. § 12131, et seq.),] [Title III of the Americans with Disabilities
40 Act of 1990 (Pub. L. 101-336; 42 U.S.C. § 12181, et seq.),] and any other applicable civil rights
41 laws, and with the applicable implementing regulations and any guidelines imposed by the
42 U.S. Department of the Interior and/or Bureau of Reclamation.

43 (b) These statutes prohibit any person in the United States from being excluded from
44 participation in, being denied the benefits of, or being otherwise subjected to discrimination
45 under any program or activity receiving financial assistance from the Bureau of Reclamation on
46 the grounds of race, color, national origin, disability, or age. By executing this contract, the

1 Tribe agrees to immediately take any measures necessary to implement this obligation, including
2 permitting officials of the United States to inspect premises, programs, and documents.

3 (c) The Tribe makes this agreement in consideration of and for the purpose of obtaining
4 any and all Federal grants, loans, contracts, property discounts, or other Federal financial
5 assistance extended after the date hereof to the Tribe by the Bureau of Reclamation, including
6 installment payments after such date on account of arrangements for Federal financial assistance
7 which were approved before such date. The Tribe recognizes and agrees that such Federal
8 assistance will be extended in reliance on the representations and agreements made in this article
9 and that the United States reserves the right to seek judicial enforcement thereof.

10 (d) Complaints of discrimination against the Tribe shall be investigated by the Contracting
11 Officer's Office of Civil Rights.

12
13 27. MEDIUM FOR TRANSMITTING PAYMENTS

14
15 (a) All payments from the Tribe to the Project Operator under this contract shall be by the
16 medium requested by the Project Operator on or before the date payment is due. The required
17 method of payment may include checks, wire transfers, or other types of payment specified by
18 the Project Operator.

19 (b) Upon execution of the contract, the Tribe shall furnish the Contracting Officer with the
20 Tribe's taxpayer's identification number (TIN). The purpose for requiring the Tribe's TIN is for
21 collecting and reporting any delinquent amounts arising out of the Tribe's relationship with the
22 United States.

23
24 28. CONTRACT DRAFTING CONSIDERATIONS

25
26 This Contract has been, negotiated and reviewed by the parties hereto, each of whom is
27 sophisticated in the matters to which this Contract pertains. Articles 1 through 13 of this
28 Contract have been drafted, negotiated, and reviewed by the parties, and no one party shall be
29 considered to have drafted the stated articles.

30
31
32 29. CONSTRAINTS ON THE AVAILABILITY OF WATER

33 (a) In its operation of the Project, the Contracting Officer will use all reasonable means to
34 guard against a condition of shortage in the quantity of water to be made available to the Tribe
35 pursuant to this Contract. In the event the Contracting Officer determines that a condition of
36 shortage appears probable, the Project Operator will notify the Tribe of said determination as
37 soon as practicable.

38 (b) If there is a condition of shortage because of errors in physical operations of the Project,
39 drought, other physical causes beyond the control of the Contracting Officer or actions taken by
40 the Contracting Officer to meet current and future legal obligations, then no liability shall accrue
41 against the United States or any of its officers, agents, or employees for any damage, direct or
42 indirect, arising therefrom.
